



OUR PURPOSE





The Wellington Chamber of Commerce's purpose is to support, facilitate and represent Wellington businesses.

AIM

This bootcamp will equip businesses with the tools they need to begin their sustainability journey, leading Wellington towards a net zero-carbon economy by 2050.

A community of climate action champions will be created, supplying ongoing support and action.

COMMUNITY FOCUS



Our partners at Te Awe Māori Business Network will help to co-create this project, to ensure we are inclusive of all communities. We intend for small to medium Māori owned businesses to benefit from this project too by participating in the bootcamp.



With 3500 members across the central region, many of these are members of the Wellington Chamber of Commerce.

We also work along side the Pacific Business Network, which will further expand our reach.

So, this programme will reach a broad and diverse range of businesses.

Pre- and Post- bootcamp surveys



Prior to the bootcamp commencing, all participants will be sent a survey to assess current sustainability understanding, challenges and desires. They will also create learning goals for each of the 6 sessions, based on the learning outcomes.




Participants will reflect on what they have learnt and how successful the event was, suggesting any alterations for future events. Participants will refer to their learning goals and assess whether desired learning outcomes were achieved.



Five months post-event, all participants will be sent a check-in survey to track their progress since the Sustainability Bootcamp and whether they have followed through with the plan created in their advisor session.

SESSION ONE: Whetu Rangihaeata



Bicultural understanding of sustainability. Sustainability from a mātauranga Māori lens. Māori deities, tikanga and mana - all relating back to a sustainable way of living.

• Whetu Rangihaeata has recently joined Business Central to provide te reo me ona tikanga lessons to companies and organisations throughout the country. Whetu a registered teacher, is an extremely passionate te reo educator and is always willing to share his culture with those who are willing to learn.

• The Sustainability Trust is a Wellington CBD eco-centre that is focused on supporting people to reduce their impact on the environment.





- Explore ways to grow the regional reach of the Enviroschools approach and to foster the depth of practice across the Enviroschools Network.






















