We, Dartrey and Ann Lamb, oppose this attempt to rezone 320 The Terrace from "Inner Residential" to a Institution Precinct foral the following reasons.

- 1: We do not want any more student accommodation in the Kelburn Terrace or Te Aro residential areas.
- a: We have lived and owned property in Te Aro since 1994, but since the building of the Te Puni Student accommodation block and the resulting flood of students, we have seen a huge rise in anti-social behavior, drunkeness and littering. If the Council allows the rezoning of 320 The Terrace and Victoria University build even more student accommodation then the situation will become intolerable for local residents/rate payers.
- b: We have no confidence what so ever in the University's ability or desire to control/manage their student's behaviour as they have shown no inclination to do so in the past.
- c: As rate payers we do not wish to be dis-enfranchised by not being publicly notified of all applications.
- 2: We do not want any more nocturnal noise.
  - a: Since the construction of the Te Puni block our quality of life, especially in the evening, has sadly deteriorated due to the hoards of noisy, drunken students rampaging down Buller Street, formally Vivian Street, to the city's bars. Their screaming, yelling and disorderly behaviour disturbs the peace of citizens on a regular basis.
  - b: Huge increase in litter, discarded bottles etc., and graffiti not only down grades the suburb, but costs the Council to clean up and remove.
