We, Strathmore Park Residents Association Inc wish to be a party to the following proceedings of the:-

 Appeal by Wellington International Airport Ltd on the Wellington District Plan Decisions for Hearing Streams 1 – 5

We are an organisation who made a submission about the subject matter of the appeal proceedings.

We are not a trade competitor for the purposes of section 308C or 308CA of the Resource Management Act 1991.

We are directly affected by an effect of the subject of the appeal that—

- (a) adversely affects the environment; and
- (b) does not relate to trade competition or the effects of trade competition.

We are interested in the part of the proceedings related to Airport Noise:

We are interested in the following particular issues:

- Airport Noise including air noise overlays, subdivision and development within the
  air noise overlay, reverse sensitivity effects on Wellington International Airport, high
  and moderate noise areas, noise acoustic treatments within airport noise overlays of
  high/moderate noise areas, management of noise sensitive areas around Wellington
  Airport.
- Airport Land use provisions to minimise environmental nuisance and/or visual degradation to residents.
- Any other matters Wellington International Airport Table of Appealed Provisions/ Matters, Specific Reasons for Appeal and Relief Sought (Annexure A);

We seek any amendments that clarify:

- Noise issues relating to Wellington Airport
- Airport Land use.

The relief sought is to ensure that:-

- Noise exposure from Airport operations are appropriate.
- The measures being undertaken in the District Plan are not onerous on the continued development of the local communities residential areas within the air noise overlays.
- The Wellington Airport insulation requirements of the District Plan in respect to acoustic insulation and ventilation are easily understood by the community and not onerous to the landowners. This is especially in relationship to existing buildings undergoing alterations.

- Existing buildings in air noise overlays (both inner and outer air noise overlay) are considered in the Quieter Homes Programme of Wellington Airport.
- Land use considerations do not result in any further impositions to residents wellbeing

As representatives of the residents of Strathmore Park Suburb we consider that members of our community are directly affected by Noise provisions within the District Plan and that we have a valid role in advocating for their wellbeing.

Note we also advise that we are separately making application to also become party to the Appeal by Kainga Ora - Homes and Communities against "decision by Wellington City Council on Proposed District Plan".

We agree to participate in mediation or other alternative dispute resolution of the proceedings.
