## Statement of Evidence from Wellington City Council Environmental Reference Group Submitter 377

Presented 11:00am Wednesday May 1 2024 to the WCC District Plan Hearings Panel chaired by Commissioner Trevor Robinson.

Thank you for the opportunity to speak to the hearings panel. My name is Michelle Rush, I am the Co-Chair of the Wellington City Council Environmental Reference Group. (ERG) Our group comprises environmental professionals representing a range of ages, skills and backgrounds on environmental matters.
