To the Public, and all people occupying Council land at Shelly Bay

The Chief Executive of Wellington City Council has determined to close Council land at Shelly Bay (as shown on the below map) to protect the public from health and safety risks in and around the buildings and land.

The Council will erect fencing to identify what areas are closed to public access.

Access to or occupation of closed areas is not permitted from 6pm, 17 November 2021.

The public road through Shelly Bay remains open.

Conditions For Access And Use Of Public Land At Shelly Bay

It is necessary to close part of the Council land at Shelly Bay (Closed Area) because of health and safety risks to the public. The Council has fenced off the Closed Area to prevent public access to it.

The conditions below are made by the Council under clauses 3.1 and 4.1 of Part 5: Public Places, of the Council's Consolidated Bylaw 2008 (Bylaw), to restrict activities on the carparking area near the Guard Hut (Alternative Area) as identified in the attached diagram.

Under the Bylaw the Council may revoke, amend, or update these conditions from time to time.

Any activities undertaken by the public on the Alternative Area must comply with all of the following conditions:

No person may access the Closed Area except with the prior consent of the Council, in the presence of a Council officer, and in accordance with any relevant management plan. Access to or use of any of the buildings at Shelly Bay could pose risk to the health and safety of persons or property and is not permitted.

No person may do anything that causes damage to any building or fence, including defacing any building, fence or Council signage.

Any activity associated with camping or peaceful protest must not unreasonably interfere with the right of all other members of the public who are free to access and use Shelly Bay. This includes members of the public seeking the pass and repass on the public road, and construction contractors or workers undertaking work permitted by Council on either the Open or Alternative Areas. No person may interfere with or disrupt any persons accessing or undertaking work at Shelly Bay (including any works on private land adjoining Council land).

Any occupation should remain peaceful and no person on Council land may commit any offences (including entering Council owned buildings, threatening or disorderly behaviour, obstructing a public access way, or wilful damage).



All persons camping or otherwise protesting peacefully use the Alternative Area at their own risk. The Council takes no responsibility for the safety of any person.

All protestors must comply with the Wellington Consolidated Bylaw 2008 (including without limitation Part 5-Public Places).
