WELLINGTON NIGHT MARKET SATURDAY 7 AUGUST 2017 TO 11 AUGUST 2018

Description of Event

The Coolest Street in Wellington, in the Coolest Capital of the World.

This event has been running for the last 12 months and has received a lot of support from residents, retailers and members of the public. The organisers would be like to extend the Wellington Night Markets success through to 2018.

It is a popular place where people can come every week, to find something new, to try something different to eat, to shop, to play and enjoy.

Generally businesses and residents support the ongoing operation of a night market.

The proposed road closure is for **Manners Street** (between Taranaki Street and Cuba Street except buses)

Cuba Street (between Manners Street and Wakefield Street)
Saturday's only 7 August 2017 to 11 August 2018 from 3pm to 11.30pm excluding setup and breakdown

Road closure notification boards will be placed at each end of the closure at least one week prior to the event.

The event will be managed by a qualified temporary traffic management company. Pedestrians access will not be restricted and emergency services will have immediate access to the area if required.

The Events Directorate has no connection with and no objection to this event.

5. Traffic Impact Assessment

Prior Closures

Lower Cuba Street has been closed each Saturday from 3pm to 11.30pm for the past two years to accommodate the Night Market. This has caused little disruption to the traffic and buses. Lower Cuba Street, at its inception, was designed as a place for events, street markets and the like. Lower Cuba Street is not regarded as an important link in the city's roading network and merely provides access to local parking and servicing. In this regard Lower Cuba Street can be closed more frequently than is anticipated by clause 11(e), section 10 of the LGA 1974.

So using clause 11(d) of this section we are recommending that traffic be diverted from Lower Cuba Street and Manners Street (between Taranaki and Cuba Street) on Saturdays for the next year. With exception being buses. This will be reviewed again in a year time.

In giving approval to the Night Market we are not excluding events like Cuba Dupa, Jazz Festival, Film Festival or any other proposed event which take priority if they require use of the street.

Traffic Impact

In the opinion of Stephen Harte Implementation Manager, Network Improvements, acting as the Council's Traffic Engineer, the proposed closure, if implemented according to an approved traffic management plan, is not likely to impede traffic unreasonably subject to the conditions listed below. However, the Council reserves the right to modify this opinion at any time. If, in the opinion of the Council, the closure may or does impede traffic unreasonably, any approval granted by the Regulatory Processes Committee may be revoked and the event organiser may be required to open the road at the direction of a suitably qualified Council officer in charge of traffic.

Conditions:

- The road closures will start at 3pm and finish at 11.30pm each Saturday. The event organiser
 is to obtain Council approval on the details of a traffic management plan prior to the event.
- . The detour route is to be clearly signed during road closures.
- Only authorised vehicles will be allowed within the road closure area, travelling at no more than Walking speed (3km/h) to ensure public safety is not compromised.
- The event organiser will publicise the event via media releases, letter drops and advanced signage to notify the public of the road closures. The event organiser is responsible for the ongoing maintenance of the temporary traffic management plan during the road closures.
- The event organiser is to ensure buses are able to enter Manners St during the road closure timeframe.
- The event organiser is responsible for maintaining public safety within the road closure area.
- The event organiser is to consult and gain approval from the emergency services on the road closure and provide access for emergency vehicles.

WELLINGTON CAR CLUB – SHELLY BAY SEALED SPRINT SUNDAY 1 OCTOBER 2017 7AM TO 6PM

1. Description of Event

The Wellington Car Club wish to run a Motorsport New Zealand sanctioned race, under their approval by way of an Event Organisers Permit. The regulations and other relevant documentation are endorsed by the Motorsport New Zealand Area Steward. This event has been held for a number of years on the Shelly Bay course, which is approximately 2.6km long.

It is proposed to close **Massey Road** (at Scorching Bay Reserve, and the northern entrance to the former Shelly Bay Defence Base) **from 7:00am to 6:00pm on Sunday 1 October 2017**, with the start line located at Point Gordon.

Public notification signage will be erected at least 10 days prior to the event. Marshals (15 in total over the entire closure), with detour maps available, will be in place at the intersection of Miramar Ave and Shelly Bay Road, and at the intersection of Awa/Karaka Bay Roads and Marine Parade. Marshals will assist traffic by redirecting them with maps if required. Emergency access will be from either Shelly Bay Road or Karaka Bay Road and will be assisted by marshals. Marshalls will control where the main walking tracks meet the road and at pedestrian crossings points. The event is to be traffic managed using a Council approved traffic management plan which will be based on the Club's own traffic management and event safety plan.

Residents and businesses directly affected by the road closure (those within the closed area or directly adjacent to the closed area) will be notified by letter drop prior to the event. The road closure will be advertised in the Dominion Post.

JOHNSONVILLE CHRISTMAS PARADE SATURDAY 2 DECEMBER 2017

Description of Event

The Northern Wellington Festival will this year be held on the 2 December 2017. The highlight of the weekend of events is always considered to be the Lions Club of Johnsonville Christmas Parade — proposed this year to be held on Saturday 2 December 2017. This non-profit event is similar to that run in previous years and seeks to bring the community together in an enjoyable pre-Christmas celebration. The event is well supported by the community, including local businesses and the local Police. The Johnsonville Lions Club has a core of very dedicated members, organisers and marshals who put a large amount of un-paid time and effort into this event. The Christmas Parade itself attracts thousands of spectators and involves many local participants and floats. The proposed road closures are required for the parade set-up, the parade itself and for the temporary traffic detour route.

The proposed road closures are:

- Wanaka Street (6am to 1.30pm)
- o Dr Taylor Terrace (6am to 1:30pm)
- Moorefield Road (between Haumia Street and Johnsonville Road roundabouts 10.45am to 12:00pm)
- Moorefield Road (between Johnsonville Road and Middleton Road roundabouts 11am to 12:30pm)
- Rotoiti Street (closed to through traffic 11am to 12:30pm)
- Broderick Road (Phillip Street to Johnsonville Road 11am to 12:30pm)
- Johnsonville Road (from Fraser Avenue intersection to Moorefield Road roundabout 11am to 12:30pm)
- Frankmoore Avenue (between Earp Street and Moorefield Road 11am to 12:30pm).

No Parking 6.30am to 3pm unless specified

Moorefield Road (western side from Wanaka Street to Frankmoore Avenue).

No Parking 7am to 1pm - Bannister Avenue, Broderick Road (Bannister Avenue to Phillip Street), Phillip Street, Frankmoore Avenue (Phillip Street to Earp Street), Earp Street.

Detour Route - Johnsonville Road, Fraser Avenue, Haumia Street, Bannister Avenue, Broderick Road, Phillip Street, Frankmoore Avenue, Earp Street, Ironside Road, Middleton Road and State Highway 1.

The event does cause some disruption to traffic in the area for a period of approximately 2 hours. There are also extensive no parking areas to allow for the traffic detour route, the parade route and the parade set-up. The temporary road closures, no parking areas, detour route and the Parade itself will be managed by a combined team of the local Police, Lions Club marshals, a registered traffic management company and Parking wardens. Council officers work with the organisers to identify

areas of the event that need improvement from year to year. Pedestrian access will not be restricted and emergency services will have immediate access to the area if required.

Approved public information signage will be in place well ahead of the event. Residents affected by the road closures, detour and no parking areas will be notified by way of letter drops and notification signage. Buses will be diverted to the bus stop outside the Post Office in Johnsonville Road to replace the Railway Station stop (the same arrangement as previously used).

The Events Business Unit has no connection with, and no objection to, this event.

The public notice that the Council is proposing to consider this closure was published in the following newspaper:

5. Traffic Impact Assessment

Prior Closures

None of the proposed closures for this event will result in a road being closed for an aggregate of more than 31 days in any year.

Traffic Impact

In the opinion of Stephen Harte Implement Manager Network Improvements, acting as the Council's Traffic Engineer, the proposed closure, if implemented according to the plans provided, is likely to impede traffic flows on a major route. The proposed conditions below will mitigate some of the expected traffic congestion during the road closures. The expected congestion during the road closures is part of facilitating a public event and ensuring safety for the general public. However, the Council reserves the right to modify this opinion at any time. If, in the opinion of the Council, the closure may or does impede traffic unreasonably, any approval granted by the Regulatory Processes Committee may be revoked and the event organiser may be required to open the road at the direction of a suitably qualified Council officer in charge of traffic.

Conditions:

- The road closures for the parade route only will start at 10:30am and finish at 1:00pm.
- The detour route is to be clearly signed during road closures.
- No public vehicular traffic will be allowed within the road closure area to ensure public safety is not compromised.
- The event organiser will publicise the event via media releases, letter drops and advanced signage to notify the public of the road closures.
- The event organiser is responsible for the ongoing maintenance of the temporary traffic management plan during the road closures.
- The event organiser is responsible for maintaining public safety within the road closure area.
- The event organiser is to work with the public transport operators to provide alternative public transport routes and bus stops.
- The event organiser is to ensure that the emergency services (Police, Fire and Ambulance Services) have been consulted with and that the Traffic Management Plan includes all of their specific requirements.





APPROVAL OF A NAME FOR WALKWAY OFF THE TERRACE

Purpose

1. The purpose of this report is to seek approval to name the walkway as shown on Plan F 3089.

Summary

2. This is a proposal to assign the name Kake Tonu Way to the pedestrian walkway off The Terrace in Te Aro.

Recommendations

That the Regulatory Processes Committee:

- Receive the information.
- 2. Agree to give approval for the name Kake Tonu Way to be allocated to a pedestrian walkway as show on F 3089 (Attachment 1).


Background

- 3. The City Safety Team, Community Services is working on a rejuvenation project for the walkway. The walkway is part owned by the Wellington City Council and part owned by the Ministry of Education.
- 4. The walkway is a main pedestrian pathway between Victoria University's Boyd Wilson Field and The Terrace. It passes through Te Aro School land and then along Council land. The walkway has a high volume of pedestrian traffic both during the day and at night. A recent survey by Victoria University Security Staff recorded approximately 2000 users in a 24 hour period, on a Friday and Saturday. This has been calculated from reviewing CCTV footage. (Attachment 2).
- 5. While the pathway is predominantely used by university students commuting to and from University/Te Puni Village Student Hostel, there is also a large number of Te Aro School students and neighbouring residents who utilise the pathway.

Discussion

- Over the past few years there have been a few high profile incidents on the walkway, which have resulted in some users and the broader public having negative perceptions of the space and feeling unsafe to use the walkway.
- 7. In February 2017 a safety audit was undertaken and it was recommended that Council should look at a rejuvenation project for the the walkway. Since then Wellington City Council has been working with the local community (Te Aro School, Victoria University, Victoria University Students Association, neighbours and Police) to identify and implement actions to enhance the safety of the space and create a positive identity and connection to the area.

These agreed actions include:



- Increased maintenance of the space ensuring that trees and foliage are well maintained
- Install a CCTV camera at the top of the stairs. There are existing cameras on the
 walkway owned the by the university. The new camera's coverage will connect up
 with the view of the cameras owned by the university and will also see down the
 steps onto Buller Street.
- Earthworks to improve sightlines along the walkway
- Develop a community art project to brighten the space, enhance ownership of the area and create connection between users.
- Naming of the walkway
- 8. Currently, the walkway has no name, the project group has agreed that as one of the agreed actions, providing the walkway with a positive name, which reflects the community will help shift people's perception of the area and also enable them to establish a positive connection with the space.
- 9. On a practical level as the walkway does not have a name, response teams are unable to assign incidents to the walkway they are generally assigned to the nearest property. Having an officially recognised name will provide a geographical reference specific to the pathway. This will allow Council and Police to pull reports specific to the walkway and provide evidence for future planning decisions.

Consultation

- 10. The City Safety Team has been extensively involved in consultation with Te Aro School, Victoria University Student Association, neighbours and Police as outlined following:
- 11. Te Aro School/Victoria University/Victoria Students Association (VUWSA)

Consultation for a name for the walkway has been done in parallel to the development of a mural design for the stepped part of the walkway. On May 29th a workshop facilitated by the mural artist Joe McMenamin was held at Te Aro School with students from Te Aro School, Victoria University and VUWSA. The objective of the workshop was for the students to provide input into the design and colour scheme of the mural and also to brainstorm names for the walkway.

The students were asked to think about names which reflect their connection to the space. There were many suggestions including Taco Cat Alley and Unicorn Alley, however the most suitable and relevant was suggested by one of the Te Aro School students who recommended their school whakataukī (proverb) – "Kake Tonu" which translates to "Ever Upwards".

12. Neighbours/Residents Associations

A letter was delivered to all of the properties which neighbour the walkway. They were invited to submit their ideas for potential names. The location of the walkway meant that potentially four resident associations could connect with this walkway. An email was sent out to Inner City Welington, Flagstaff Hill Residents Association, Aro Valley



Community Council and Greater Kelburn Progressive Association inviting them to share this with their community and submit potential names.

We received the following recommendations:

- Wahine Toa
- Aroha.
- 13. As a result of this consultation, the City Safety Team has engaged with local iwi through the Council's Treaty Relations Team, to find out if the site was significant to Maori and for their thoughts on the suggested name "Kake Tonu Walkway" and "Te Ara Poutama"

They received a response from Morrie Love regarding Kake Tonu – the PNBST Trustee for the Environment and Resource Management "I am happy with that – I have a moke at Te Aro School – they are a great group".

The Treaty Relations team were happy with both Kaku Tonu Walkway or Te Ara Poutama, however they preferred Kake Tonu Walkway as it connects directly with Te Aro School.

Potential names

The table below provides a list of the suggested names and their meaning

Suggested Name	Meaning (provided by submitter)
Wahine Toa	Wahine toa means strong women - in recognition of the history of this pathway (site of men sexually assaulting women) to rise up against this negative aspect and give renewed strength and mana to the pathway and the people who walk on it - especially women.
Aroha	Aroha means love – Aroha incorporates Aro, the name of this precinct and turns this pathway into a positive space, strength in unity and connection with the community.
Kake Tonu Walkway	Kake Tonu is the whakatauki of Te Aro school. It also reflects the culture of the space as a learning hub and draws on connection between the School and University through the growth of learning and moving upwards in your education. On a more practical level the name works well as you are literally walking up stairs.
Te Ara Poutama	'Te Ara Poutama'. Poutama symbolises the steps up to gaining knowledge so



links very closely with education and
also the school whakatauki. It also links
in when starting at primary and climbing
the steps up to tertiary education. Ara is

Recommended Name

- 10. The City Safety Team has looked at the suggested names and believe that "Kake Tonu Walkway" which translates to "Ever Upwards Walkway" is best suited to achieve our objective of creating a positive identity for the walkway which users can connect with.
- 11. Walkway is not a permitted road name type according to the Australian Standards, so in the recommendations it has been changed to 'Way".
- 12. Kake Tonu is the whakataukī of Te Aro school. It also reflects the culture of the space as a learning hub and draws on connection between the School and University through the growth of learning and moving upwards in your education. On a more practical level the name works well as you are literally walking up stairs.




