# **Purpose**

1. This report asks the Regulatory Processes Committee to approve the temporary closure of roads to enable events to take place.

     Rain Day Sunday 15 November 2020 6.00 am to 11.30 pm
  - Newtown Festival Street Fair Sunday 7 March 2021 5.00 am to 9.00 pm

# Recommendation/s

That the Regulatory Processes Committee:

- 2. Agree to close the following roads and sections of the roads for the events (as Listed below) to vehicles and cycles only, subject to the conditions listed in the proposed Road Closures Impact Reports:
  - Gazley Volkswagen Wellington Marathon Sunday 30 August 2020 6.00 am to 1.00 pm
    - Seaward lane closure (2 lanes) 6.00 am to 10.00 am Sky Stadium traffic lights along Waterloo Quay, Custom House Quay and Jervois Quay to Cable Street.
    - Seaward lane closure (1 Lane) 10.00 am to 1.00 pm Sky Stadium traffic lights, along Waterloo Quay, Customhouse Quay, Jervois Quay, to Cable Street. This is for outward section of all races using two of the three lanes until Jervois Quay, where it will gradually funnel down to one lane at Cable Street. Marshalls will help residents access Herd Street from 7.30 am to 11.30 am. Residents, business owners, Te Papa visitors and market goers will have controlled access.
    - Seaward lane Closure 6.00 am to 1.00 pm Cable Street to Oriental Parade 6.00 am to 10.00 am
    - Oriental Parade to Evans Bay between Cable Street and Cobham. Full road closure would be in place between 6.00 am to 12.00 noon. Landward lane for normal westbound traffic would be open by approximately 11.00 am. Residents and business owners would have controlled access.
    - Shelly Bay Road between Miramar Avenue and Scorching Bay 7.00 am to 11.30 am. Residents and business owners will have controlled

# **Background**

3. The Council receives numerous requests throughout the year for public roads to be closed for public and private events. In order for the closures to have effect, under Schedule 10 of the Local Government Act 1974, council approval is required.

- 4. The authority to approve requests for road closures is made under Schedule 10, clause 11e), of the Local Government Act 1974 and the Transport (vehicular Traffic Road Closure) Regulations 1965. This authority is delegate to the Regulatory Processes Committee.
- 5. This report has been prepared in accordance with the procedures that were approved by the Committee on 15 December 2010. In summary, these are:
  - An event organiser applies for a road closure where a proposed event requires one.
  - Council officers receive the proposal and assess the merits and need for a road closure.
  - The Council advertised its intention to close the road in the public notice column of the local newspaper and on social media.
  - Together with the event organiser, Council officers ensure consultation with affected stakeholders is carried out and a communication plan is formulated.
  - Any Objections are followed up and resolved as far as practical.
  - The event organiser works together with Council officers who modify any plan in response to public submissions and prepare an impact report for the Committee.
  - Council officers recommend any conditions that should apply to the approval.
  - The Committee deliberates on the proposed road closure.
  - A Council officer notifies the event organiser of the Committee's decision.
  - If the proposed closure is approved, Council officers ensure the event organisers
    follow the agreed communications plan including notifying the public and affected
    parties. The event is also monitored to ensure the traffic management plan is
    adhered to and any associated conditions are followed to keep the public safe
    and to avoid any unreasonable impact on traffic.

# **Discussion**

6. These events are held annually and the event organisers apply for permission every year.

#### **Public Notification**

- 7. Members of the public have been advised of the road closures and informed of their right to object
- 8. The public notice advertising that the Councils is proposing to consider this closure was notified via the following channels:
  - Dominion Post
  - Facebook
  - Twitter
  - Have Your Say

- 9. Event organisers are working with resident groups where applicable, community groups, local retailers and businesses and have advised them of their intention to close the road.

11. This proposed road closure is subject to the Government Covid-19 guideline announcements (or any subsequent announcements) regarding events of this nature. Government timelines will dictate any postponement date should it be required.

## **Objections**

12. No objections have been received for the proposed events

## **Impact Assessment**

- 13. A temporary plan will be prepared by a Council approved traffic management company for approval by Council prior to the event.
- 14. Any objections as a result of the road closure will be dealt with before the event.
- 15. The proposed closures (when implemented according to the approved temporary traffic management plan) are generally considered unlikely to unreasonably impede traffic. A detailed impact report for each event, including conditions placed on the event organiser is attached.

# **Options**

- 16. Option 1: Agree to the temporary road closures.
- 17. Option 2: Do not agree to the temporary road closures. If you choose this option then the events relying on the road closures will not be able to go ahead.

## **Next Actions**

18. If the proposed road closures are approved, the event organiser will issue further public notices advising of the approved closures, implement the approved traffic management plan, run the event and clean the site. Council officers will monitor the impact of the closures and debrief with the organisers following the conclusion of the event.

# SPRING INTO TAWA SATURDAY 17 OCTOBER 2020 5AM TO 5PM

#### 1. Description of Event

"Spring into Tawa" is Tawa's annual spring festival. It is held in Main Road, Tawa, and provides an opportunity for local retailers, community groups, education providers, and families to gather together. The event features stalls selling a range of products – including baking, crafts, gifts and household items.

The event is also an opportunity to showcase all the activities that are on offer in the community – including swimming, music, entertainment, gymnastics and recreation. The festival is a key fundraising opportunity for many of the community groups and organisations and is well supported by local schools and early childhood education providers.

The event has reached its limit in terms of the space available on the footpath and the plaza area and the community organisers would like to see it grow, with more space to enjoy activities. Therefore, it is proposed to close a small section of Main Road to provide a larger space for the event to grow and spread out.

#### The proposed road closure is: Saturday 17 October 2020 5am to 5pm

Main road (between Lyndhurst Road intersection and Surrey Street roundabout)

Please refer to map Attachment 1 for further details

Parking restrictions will be in place to relocate Taxi Stand and Bus Stops.

The road closure is to be carried out under an approved temporary traffic management plan.

Road closure notifications signs will be placed at each end of the closure at least 10 working days prior to the event. Residents and retailers will receive a letter advising them of the event and the road closures and parking restrictions at the same time. The road closure is to be managed by a qualified traffic management company. Emergency services will have immediate access to the area if required.

The Events Directorate has no connection with and no objection to this event.

Tawa retailers, community groups, local schools, kindergartens & Tawa business incorporated group do participate in the Spring into Tawa. Due to Covid 19 the April 2020 communication letter drop didn't go ahead. Letter drop will be done week of 25<sup>th</sup> – 31<sup>st</sup> May, a reminder letter drop will be sent late September 2020 and the final communication will be done early October 2020 before the event.

This is a regular annual event and in 2019 there were no issues.

#### 4. Objections

The event organiser has advised the New Zealand Police and the Ministry of Transport, no objections have been received.

There have been no objections to this proposed closure from the public.

#### 5. Traffic Impact Assessment

#### **Prior Closures**

The road closure is proposed under the powers provided to Council under the Local Government Act 1974, Section 10. Stopping and closing of roads, Schedule 10: <u>Local Government Act 1974, Section</u> 342, Schedule 10

#### **Traffic Impact**

Council officers consider that, the proposed closure, if implemented according to an approved traffic management plan, is not likely to impede traffic unreasonably subject to the conditions listed below

#### Conditions:

- The road closure is valid from 5am to 5pm on Saturday 17 October 2020
- The event organiser is to notify the public via letter drop to affected parties, advanced signage and media releases.
- The event organiser is responsible for safety (pedestrian and traffic) within the closed area.
- The event organiser is to provide marshals at all road closure ends to ensure that public safety (interaction of traffic and spectators) is not compromised. This is essential where road closures transition from partial to full closures and vice versa.
- The event organiser is to ensure emergency services (Police, Fire and Ambulance Services)
  have been consulted with and the Traffic Management Plan includes all of their specific
  requirements.
- The event organiser is to ensure that the affected property and business owners along the road closures are advised and consulted with.
- The event organiser must have a Health and Safety plan, which covers how emergency vehicles are required to enter the road closure site if required 10 days before the event.

- The event organiser is to provide full details of the Traffic Management Plan to Council for approval no later than ten (10) working days prior to the event.
- Information signs must be installed ten (10) working days before the event.
- The event organiser must provide Council with an Event Hazard/Risk Management plan ten (10) working days prior to the event that describes in full how the event organiser will manage all Health and Safety risks associated with the event.
- The event organiser is to work with the public transport operators to provide alternative public transport routes and bus stops along the proposed partial and full closures.
- Detour routes are to be provided with adequate signage during the road closure period.
- The event organiser is to provide adequate detour routes to provide access for affected residents and businesses during the event, within the Health and Safety plan.
- The event organiser must organise a debrief session (minutes must be taken) as close as
  possible after the event with all affected parties. These findings must be recorded and
  distributed to attending parties.
- This proposed road closure is subject to the Government Covid-19 guideline announcements
  regarding events of this nature. Government timelines and amount of people allowed to
  congregate will dictate any postponement date should it be required.

However, the Council reserves the right to modify this opinion at any time. If, in the opinion of the Council, the closure may or does impede traffic unreasonably, any approval granted by the Regulatory Processes Committee may be revoked and the event organiser may be required to open the road at the direction of a suitably qualified Council officer in charge of traffic.

#### 1. Description of Event

The Polish Christmas market has been held in the Dom Polski (Polish House), 257 Riddiford Street, Newtown since 1956. Last year there was overwhelming support for this market, so to cater for the growing number of participants an application has been made to hold it on the street this year.

Dom Polski has an extensive frontage along the Riddiford Street end of Rhodes Street and it is therefore proposed to use this section of Rhodes Street through to Ferguson Street, and also nearby Amey Street to hold the Christmas Market this year. If this is a success, the organisers will look at continuing to use Rhodes Street and Amey Street in the future.

#### 1. Description of Event

The annual Newtown Festival and Fair is a successful community event attracting very large crowds. Newtown Festival started over 10 years ago as a small community fair and has grown to include 12 stages and over 420 stalls. It is held on the first Sunday in March every year.

This event is run by the Newtown Festival Community that involves retailers, residents, community groups and over 200 volunteers are involved.

Parking restrictions are proposed on the above and some surrounding streets. A one-way system for Eastern and some Southern bus services will operate on Daniell Street and Owen Street via Mein Street, which remains two-way at all times. Busses to and from Island Bay will be diverted to the number 4 route which runs via Adelaide Road. The traffic diversion, emergency procedures and the fair footprint are an established format that Council officers, local community, emergency services and the traffic management company have collectively reviewed and used on previous occasions.

Pedestrian access will not be restricted and emergency services will have immediate access to the area if required. Public transport operators have been notified of the proposed closure,

Road closure notification signs will be in place at least 10 working days prior to the even, as well as electronic message boards on the event day. Residents and local businesses will receive a letter drop advising them of the event, road closures and parking restrictions.

This event is also extensively advertised by posters in local shops and a variety of other media in the week preceding the festival. The traffic during the event is to be managed by a qualified traffic management company. Emergency services will have immediate access to the area if required. Public transport operators have been notified and consulted with over the road closures. Agreement has been reached on suitable temporary bus stops and detour routes for the event with Greater Wellington Regional Council.

# 1. Description of Event

Established in 1986, the Wellington Marathon is one of New Zealand's leading running events. It is organised by the Wellington Marathon Clinic. The event involves the classic 42.2 km full marathon, half marathon 21.1 km, 10 km, 5 km and a kid's magic mile with approximately 5,000 runners and walkers taking on these events.

Since 2003, when the event shifted to Westpac Stadium venue and current route, the Wellington Marathon has seen greater than 400 percent growth rate.

It is now a member of New Zealand's "Big Five" marathon events, alongside the Auckland, Queenstown, Rotorua and Christchurch marathons. The event attracts more than 2,000 visitors every year, and is regarded as Wellington region's major winter event.

In 2020 the event will follow the same route and be managed in the same way as the last three years.

The proposed event will follow a scenic route commencing from Sky Stadium along Waterloo and Jervois Quays, Cable Street, Oriental Parade, Evans Bay Parade, Cobham Drive, Shelly Bay and Massey Road, returning via the Wellington Waterfront.

A full Traffic Management Plan (TMP) will be required as part of the events approval. A qualified traffic management provider will prepare the TMP and manage the controls on race day.

Additional marshals will be used to further ease any impact on the public. Herd Street, being a private access road, will be managed separate to the rest of the course. Public awareness of the event will be raised earlier this year by

- Earlier delivery of letters to residents and businesses.
- Improved utilisation of WCC website and social media avenues.

As for previous years the event has the support of Sky Stadium, Wellington City Council Events office and the Oriental Bay Residents' Association and we continue to work with all stakeholders to reduce any inconvenience. In the past three years increased resource around course management, traffic management and public notices has seen the event minimise any disruption on the public. The course will only be closed for a few hours, and will re-open by 1.00pm.

# The following proposed road closures are required on: Sunday 30<sup>th</sup> August 2020 from 6.00am to 1.00pm

- Seaward lane closure (2 lanes) 6.00am to 10.00am
- Sky Stadium traffic lights along Waterloo Quay, Custom House Quay and Jervois Quay to Cable Street.

To safely manage the start of the event. We propose closing the left-hand lane of Waterloo Quay (just south of the stadium overbridge) through Customhouse and Jervois Quays to Cable Street. We will also close left-hand lane along the entire length of Cable Street. This worked well last year. These lane closures help accommodate runners until they reach Oriental Parade. The organisers are currently in consultation with both the Harbour side market, Te Papa and Wellington Waterfront to manage suitable site access for market stallholders, market goers, businesses and public.

The full length of Shelly Bay Road between Miramar Avenue and Scorching Bay will be closed because sections of this road are narrow and has blind corners making it difficult to safely manage traffic without closing it. This has been necessary in past years and worked well.

As well as the road closures listed above, here will be a one-way traffic system along Oriental and Evans Bay Parade which has worked successfully for the last four years. This will mean that the entire seaward traffic lane along Oriental and Evans Bay parades will be closed from Herd Street to Cobham Drive. General vehicular traffic will operate via a one way system along the landward side lane from the eastern suburbs to the city.

Event marshals will provide access to residents along the route balanced against the safety of participants.

A full TMP (to be approved by a qualified Council Officer) will be required for the event, including the single lane closures and associated parking restrictions. Additional traffic management will be in place (as for previous years) on Cobham Drive and this will require approval from NZTA.

Public notification signs will be placed at strategic points along the course at least 10 days prior to the event to advertise the proposed one way system and closures. The event is to be managed by qualified traffic management company employing suitably qualified personnel. Emergency services will have immediate access to all areas if required.
