NEW ZEALAND PLANNING INSTITUTE AND PLANNING INSTITUTE AUSTRALIA CONGRESS, GOLD COAST, QUEENSLAND, AUSTRALIA, 2-5 APRIL 2006

1. Purpose of Report

To provide information on and to seek approval for up to two elected members to attend the "Imagine Impacts²" New Zealand Planning Institute and Planning Institute Australia Congress to be held at Gold Coast, Queensland in Australia, 2-5 April 2006.

2. Recommendations

It is recommended that the Committee:

- 1. Receive the information.
- 2. Recommend that Council approve the attendance of up to two elected members at the "Imagine Impacts²" New Zealand Planning Institute and Planning Institute Australia Congress to be held at the Gold Coast, Queensland in Australia, 2-5 April 2006, and that the costs associated with attending the meeting be met from the Elected Members Budget (GVEM01).
- 3. Note that there is a Positively Wellington Board Meeting scheduled on Monday 3 April 2006, a Strategy and Policy Committee Pre-Meeting session scheduled on Tuesday 4 April 2006 and an Elected Member Session scheduled for Wednesday 5 April 2006.
- 4. Note that a report back on the meeting will be presented to the Strategy and Policy Committee in accordance with Council policy.
