# COURTENAY PRECINCT PROJECT UPDATE

### 1. Purpose of Report

To inform the Committee of progress and planned future work in the Courtenay precinct.

### 2. Executive Summary

In March 2008, the Strategy and Policy Committee agreed to a programme of work being carried out in the Courtenay precinct. That work was aimed at addressing issues associated with safety, alcohol, streetscape design and vehicular management. Most of the initiatives are underway or complete and this paper provides an update for the Strategy and Policy Committee (SPC) on the work programme.

The focus in the Courtenay precinct is currently on its use during the Rugby World Cup and a comprehensive audit of the area is planned. Officers continue to work with stakeholders to improve vehicle management and to find solutions for managing taxis in the area.

#### 3. Recommendations

Officers recommend that the Strategy and Policy Committee:

- 1. Receives the information.
- 2. Notes work is being carried out in Courtenay Place to address a range of issues including safety and vehicular management.
- 3. Notes that an audit of Courtenay Place will be carried out in order to develop a proposal for short term capital upgrades along with long term solutions for the precinct. This work will also be included in Wellington 2040.

## 4. Background

In March 2008, the Strategy and Policy Committee considered a paper on the Courtenay precinct. That paper proposed a five-year vision that the Courtenay precinct will:

- continue to develop as the city's premiere entertainment district but with greater diversity in venues and more outdoor café seating
- have a streetscape which accommodates late-night crowds and also meets the priorities of the day and evening economies
- be exciting, inviting and safe.

That paper noted that the key issues to be addressed arise from safety concerns related to the large number of people who gravitate to the precinct for late-night entertainment. The issues include:

- alcohol-related harm (disorder, criminal offending and anti-social behaviour)
- footpath and traffic congestion
- streetscape design, including lighting
- public transport and taxi management
- public place activity.

An integrated set of solutions to deliver on the five-year vision was proposed. The solutions will address the issues associated with late-night entertainment and meet the daytime and evening priorities of local businesses and public transport.

SPC agreed that work would be undertaken to revitalise the Courtenay precinct. Proposals on street lighting and CCTV were presented in June 2008 and in December 2008 SPC agreed to a pilot project to control traffic movements in Courtenay Place.

It was agreed that officers would undertake further work on the following 12 initiatives.

- Introduce a 24/7 liquor ban across the central city
- Establish an alcohol accord
- More Walkwise officers at peak times
- Install CCTV (city wide initiative)
- Upgrade street lighting Courtenay Place
- Upgrade street lighting Allen and Blair Streets
- Develop a role within Council to manage the Courtenay precinct
- Establish a late-night taxi stand and queuing system
- Facilitate summer concerts in Courtenay Place Park
- Convert the heritage men's toilet into storage and dressing rooms for events
- Develop a flexible / revitalised streetscape
- Implement bus priority at peak commuter hours (subject to further consultation)

This report provides further information on the Courtenay project.

#### 5.1 Work to date

#### 5.2 Develop a flexible/ revitalised streetscape

There are at least two streams to this initiative; one is concerned with the physical characteristics of the area (for example the assets in the area or the layout of the area) and the other with vehicular management. It can be noted that shared space was created in Courtenay Place between Tory and Taranaki

Streets for use as parking during the day and for pedestrians at night. This is expected to alleviate pressures arising from queuing in the area.

#### **Physical characteristics**

The Council is committed to ensuring that the Courtenay precinct is in excellent shape for hosting visitors to the city expected for the Rugby World Cup in 2011. To this end, officers will undertake an audit to quantify the existing assets in the Courtenay precinct. Following that audit, a proposal will be developed for short term capital upgrades for the Rugby World Cup along with long term solutions for the precinct, which will be integrated into Wellington 2040.

#### **Vehicle Management**

The Courtenay precinct has three quite different uses with different transport implications— the daytime economy which calls for amenity that supports shoppers and workers, such as short term car parking and a public transport hub; the night time economy when there is a demand for greater pedestrian space along with space for outdoor dining and/ or drinking and less demand for parking and thirdly as an events venue where road(s) may be closed to traffic.

In December 2008, as a pilot, vehicular access from Courtenay Place into Allen and Blair Streets was restricted.

In 2009 some areas of parking were removed at night. This has created safer and more pedestrian movement areas and eliminated some conflict between moving vehicles and pedestrians. Police consider this to be highly successful, telling us that it reduced the incidence of fights, accidents, injuries and private property damage. Temporary measures are being used to implement this and traffic resolutions that support permanent implementation are scheduled to be presented to SPC on 18 March 2010.

Taxi congestion late at night and in the early hours of the morning (particularly Friday and Saturday nights) has been a concern in Courtenay Place for some time. Council officers have worked with the taxi companies, police and NZTA to identify solutions. For example some additional late night taxi stands have been provided however this does not seem to be alleviating the problem. There are ongoing discussions with the taxi industry through the Taxi Forum.

#### 5.3 Consultation and Engagement

Consultation and engagement is carried out with stakeholders within each of the sub-projects.

#### 5.4 Financial Considerations

There are no further financial implications at this time although there may be some following the audit and development of a proposal for upgrading the area.

#### 5.5 Climate Change Impacts and Considerations
