#### 271/10P PETITION OF MARC O'CONNOR – THIS HARBOUR CITY OF OURS REQUIRES JETTIES AT BOAT RAMPS (1215/52/IM) (9.17AM – 9.30AM)

Morrison from AllGood Bananas, addressed the Committee about the achievements of Wellington as a Fair Trade City. Mr Barber said that Wellington was the first Fair Trade capital city in the Southern Hemisphere, a status granted one year ago. Mr Barber encouraged the Wellington City Council to adopt more measures to promote fair trade products.

2. David Zwartz and Robin Buxton from the Kelburn Progressive Residents' Association addressed the Committee and provided a history of Wellington City Council attempts to address pedestrian safety concerns in Kelburn by reducing speed limits in the area. Mr Buxton told the Committee that the Kelburn Speed Limits consultation feedback showed a large percentage of people wanted an extension of the speed limit to Upland Road. Also, Mr Buxton noted that the report did not discuss or address School Safety concerns in Kelburn.

#### NOTED:

1. Donald McDonald addressed the Committee and discussed the need for kinetic intelligence in formulating the Draft Carbon Management Policy. Mr McDonald suggested that all tenants in the Wellington Housing Upgrade Project should have thermometers installed in their homes, and use these rather than how they feel as a measurement of the temperature and the need to heat their homes.

2. Michael Taylor addressed the Committee and expressed his concern regarding the role of speculators and intermediaries in carbon trading and the financial rewards they may gain from these trades. Mr Taylor suggested that the Wellington City Council establish a resolute and binding policy for carbon management and pollution reduction, rather than aspirational and non-binding policies.

3. Nicola Gaston from Cycle Aware addressed the Committee and expressed the need to incorporate Cycling and Walking promotion

strategies in the Carbon Management Policy. Ms Gaston explained that there are a number of strategies that can be implemented immediately, such as increasing cycle parking facilities.

4. Peter Hunt and Megan Miller from Forest and Bird Wellington addressed the Committee and discussed the role of forests in mitigating carbon emissions. Mr Hunt suggested that there should be greater emphasis on the role of indigenous forests in the Carbon Management Policy, incentives for the planting of these forests and barriers to prevent their felling. Ms Miller suggested a range of options that Council could adopt to promote indigenous forests and prevent their deforestation.
