# SISTER CITIES CONFERENCE: MASTERTON, 27 – 29 APRIL 2011

## 1. Purpose of Report

This report provides information on the Sister Cities Conference 2011 to be held in Masterton from 27 to 29 April 2011, and seeks approval for one elected member to attend the conference.

#### 2. Recommendations

Officers recommend that the Committee:

- 1. Receive the information.
- 2. Approve the attendance of one elected member at the Sister Cities Conference 2011 to be held in Masterton from 27 to 29 April 2011 and note that the costs associated with attending the conference will be met from the Elected Members' budget (GVEM01).
- 3. Agree that should the nominated elected member(s) be unable to attend, they may ask another elected member to attend in their place.
- 4. Note that a report back on the conference will be presented to the Strategy and Policy Committee in accordance with Council policy.
- 5. Note that there are two meetings scheduled on Wednesday 27 April 2011 (Wellington Venues Ltd Board Meeting and Youth Council).

## 3. Discussion

The 2011 Sister Cities Conference will take a constructive look at sister cities in relation to being 'Connected, Relevant, and Rewarding' under the following themes:

- Relationships are Everything
- Sister Cities in Action
- Measuring Value and Success
- Where to Now?

#### 3.1 Conference Programme

Using a combination of key note speakers, panel discussions, workshops and brief snapshots of success stories, the conference will explore trade, tourism, education and cultural opportunities provided through the Sister Cities connection.

Programme highlights include:

- US Ambassador David Huebner the case for international friendship
- Ministry of Foreign Affairs CEO John Allen with views from NZ embassies around the world
- A series of Sister Cities in Action vignettes showing varied activities in practice:
  - "An international network in action" Sue White, Rotorua DC
  - "Building an amazing sister city event" Masterton DC and Changchun (China)
  - "Time Out in New Zealand programme for Japanese families" Jon Doherty (Terrace Downs)
  - Featherston and Messines "Just good friends" Adrienne Staples, Mayor, South Wairarapa DC
  - The Ngati Porou (Spanish) Panior Judy Livingston, Gisborne DC
- David Hancock (Hutt City) and Yvonne Tatton (Tauranga) share their approaches to measuring the value and success of sister city relationships
- Bruce Gadd (NZTE/Rugby World Cup) will look at how Sister City networks can leverage international events
- A panel representing Australia (Auckland), Japan (Wellington) and China (CPAFFC) will tackle some of the big questions facing their sister cities, including sustainability and leveraging opportunities now and in future
- Sister Cities New Zealand strategic planning session, followed by the AGM
- Air New Zealand Awards Dinner and Royal Wedding Feast

Due to the recent events in Christchurch and Japan, the key note speaker is yet to be confirmed.
