REVISED FOCUS AREAS FOR GENERAL GRANTS AND CRITERIA FOR THE COMMUNITY PREPAREDNESS GRANTS

1. Purpose of Report

To seek the Strategy and Policy Committee's approval of the focus areas and associated criteria for the general grants pools as well as the proposed criteria for the Community Preparedness Grant.

2. Recommendations

It is recommended that the Committee:

- 1. Receive the information.
- 2. Agree to the revised priorities and associated criteria for the general grants pools.
- 3. Agree to the criteria for the Community Preparedness Grants, subject to the Draft Annual Plan deliberations.

3. Background

Grants are a mechanism for achieving the Council's objectives and strategic priorities, especially those priorities that rely on community organisations carrying out specific activities.

Grants are included in the Annual Plan to provide

 A flexible, reactive mechanism for the Council to support community groups that are undertaking projects that meet a need identified by the community.

- The Council with the ability to encourage innovation, diversity and creativity.
- A mechanism to support the city's social, cultural, economic and environmental infrastructure.
- A mechanism that enables the Council to ensure particular activities occur without directly providing a service.
- Funding through contracts as a mechanism to support organisations that represent core business of the Council or directly contribute to Council's strategic or policy goals.

To ensure a more flexible approach in determining funding priorities the Grants Framework recommended priority (focus) areas be reviewed on an annual basis to align with annual plan priorities.

4. Discussion

There are common grants criteria that apply across all grant pools such as the Cultural, Social, economic and Environmental grants. Each grant type has specific criteria that relate to council's current focus (priority) areas.

Current focus areas and criteria specific for each pool come from a mixture of historical drivers and were developed to align with strategic priorities identified by Councillors in the 2006/09 period, as well as acknowledging historic areas of funding (prior to the current grants framework).

The current and proposed focus areas and specific criteria for the four general pools are outlined in the tables below.

4.1 Social Grants

The proposed focus areas and associated criteria for the social pool continue to recognise the importance of strong, sustainable communities and the need for building capacity in the community. Focus areas recognising youth, city safety and participation in recreational (passive and active) activities are also retained.

Focus areas are to support the development projects of economic benefit to Wellington. The projects must benefit the wider community (local or city wide) not individuals or businesses. Applicants should not be government agencies

4.5 Community Preparedness Grants

The Council promotes social wellbeing by providing a wide range of opportunities, facilities and initiatives which includes supporting projects that encourage community resilience and local sustainability.

Community Preparedness Grants are intended to help build strong communities by supporting local initiatives that promote and enhance resilience.

Community resilience is the sustained ability for communities to respond and recover from a crisis or emergency and a resilient community is one that has:

- Good infrastructure: secure homes and community facilities.
- Resources: personal and household emergency resources including water supplies and emergency kits.
- Knowledge and information: access to information about what to do in an emergency; household plans, tsunami evacuation routes, Civil Defence Centres, First aid.
- Neighbourhood connections: connections between households so that people are checked on – especially if they are vulnerable and information will be shared.

Community Preparedness Grants are intended to help build strong communities by supporting projects that promote connectedness at a neighbourhood level, enhance local resilience, emergency preparedness and sustainability. The activities and projects funded will contribute to the following outcomes:

- An increase in personal and household preparedness for an emergency.
- An increase in collective preparedness for an emergency.
- An increase in connectedness in the case of an emergency.

Projects must meet the general grants criteria (Appendix one) as well as the additional criteria specific for this fund. The additional criteria are:

Additional criteria

The project must:

- be a local neighbourhood initiative that impacts upon at least 15 homes or a defined geographic community such as walkways or apartment buildings
- strengthen local connectedness in a way that is sustainable and has an ongoing benefit to the neighbourhood
- increase emergency preparedness locally
- be open to the whole neighbourhood
- improve the wellbeing of people in the community
- improve how safe people feel within the community.

6. Conclusion

Officers recommend the revised focus areas for the four general grant pools (Economic, Social, Environmental and Cultural) and the proposed criteria for the Community Preparedness Grants.

Appendix One

General Grants Criteria:

- 1. Project makes a positive contribution to achieving the Council's Strategic Outcomes as listed in the Council's current Annual Plan.
- **2.** Project is Wellington based and primarily benefits the people of Wellington
- **3.** Applicant is a legally constituted community group or organisation, not an individual (may apply under an umbrella organisation)
- **4.** Applicant group provides evidence of (or, if a new group, systems for): sound financial management, good employment practice (where applicable), clear and detailed planning, clear performance measures, demonstrated ability to report back on past funding as appropriate.
- **5.** Projects will not be funded for the same purpose more than once in any financial year.
- **6.** Failure to report adequately on past Council funding can result in a group being considered ineligible for future funding.
- 7. Project is physically and financially accessible either by a wide range of persons or by the intended users.
- **8.** Project shows evidence of community support, collaboration and building partnerships with other organisations (eg letters of support from other organisations/leaders).
- **9.** Applicant must demonstrate that the project expands the capacity, range or level of similar types of services in the community and that there was user input into identifying the need for the project.
- 10. The principal intent of the project is not for private or commercial pecuniary gain, though it may be that such gains occur as a side effect of the project.
- **11.** Application demonstrates an awareness of the Treaty of Waitangi, in particular when involving Mana whenua and Taura Here.
