POLICY PROGRAMME 2012/2013 AND SPC FORWARD PROGRAMME

1. Purpose of report

This report asks the Committee to agree the policy work programme. This is attached in Appendix 2. This follows the Councillor workshop held on 14 August 2012 and the policy work has been scheduled on the Forward Programme. The Forward Programme is also attached as Appendix 1 for approval.

2. Recommendations

Officers recommend that the Committee:

- 1. Receive the information.
- 2. Agree the key priorities and the work outlined in the policy work programme attached as Appendix 2.
- *3. Agree to the Forward Programme for the Strategy and Policy Committee attached as Appendix 1.*

3. Background

This report seeks approval of the 2012/13 policy programme which was presented on 14 August 2012. The Forward Programme for the Strategy and Policy Committee (SPC) incorporates the policy work programme and this is then approved by the Committee each month.

4. Discussion

The Forward Programme reflects organisational and political priorities and emerging issues that require decisions from SPC.

4.1 Outcomes from the Policy work programme workshop

The Policy work programme is attached as Appendix 2.

In August, officers presented the policy priorities to Councillors. These were based around the Wellington Towards 2040: Smart Capital framework and the 7 strategic areas of the Long Term Plan. The presentation focused on the need for the policy programme to be agile and action focused. Officers also emphasised the need to make the most of opportunities arising in the current economic climate. To achieve this it was recommended that the work programme focus on the key pieces of work that deliver on the Council strategy.

The response from Councillors was a desire for policy to "get on with the doing". It was felt that the priorities were broadly consistent with the strategic framework but that action was now required, with the focus on outcomes rather than process. Officers have taken on board this feedback and commenced scheduling the priority pieces of work on the Forward Programme.

The key themes coming through the workshop focussed on:

- the need to ensure financial sustainability within the changing economic climate
- the need to leverage off our Capital City status, our unique physical qualities, liveability and diversity
- Wellington's ambition going beyond an Eco City focus (which may not demonstrate our uniqueness or status) and the need to better express this ambition through the brand and associated work programme
- the need to be agile, action and outcomes focused with any decisions required to drive the strategic direction.

4.2 Additions to the priority work programme

As a result of the discussion at the workshop with Councillors, we recommend the following additions made to the policy work programme. These include:

- water conservation added as a priority piece of work
- considering the Eco City work programme to better reflect the outcomes sought for the city
- adding partnerships and working with Education institutions in the City (this has been incorporated within the Capital City status priority)
- reviewing the currency of the Council's other strategies and their fit within the work programme
- incorporating diversity as a principle within the key priorities.

4.3 Councillor engagement

The scheduling of work on the Forward Programme where it provides for briefing sessions/workshop at the end of each month often does not allow enough flexibility to engage with portfolio leaders and Councillors on the range and scope of issues across the policy programme. We recommend adding Councillor briefings and workshops to the Forward Programme.

The purpose of these sessions is to;

- ensure officers can get early engagement with Councillors on issues during the development of policy papers
- ensure that there is dialogue around the policy issues so that the policy development is fully informed of Councillor and portfolio leaders views.

This does not take away from the policy papers being presented as officer advice however it should ensure that this advice is fully informed of Councillors views and that there are no surprises when policy papers are presented to the committee for decision.

These sessions can sit outside the current scheduling arrangements and it is proposed that these be scheduled throughout the week at a time suitable to Councillors. Officers wish to work with portfolio leaders and will extend invitations to Councillors interested in participating in these working sessions to address issues that are arising in the policy development process.

A schedule of topics is outlined below and these have been added to the Forward Programme where dates have been able to be identified. The remainder are on the "to be scheduled" list and will be scheduled as the policy development progresses.

Managing lower order priorities

Officers are exploring ways in which policy issues for lower priority work can be addressed without the need for an expensive and time consuming policy process. This will help to ensure resources are dedicated to key pieces of work and minimise unnecessary bureaucracy and any associated delays and cost.
