2. Oral Reports

2.3 Community- Led Climate Adaption Update – Jacqui Hastie

Item 2.3 was presented first as Jacqui Hastie requested to leave early due to family responsibilities. Jacqui updated the Board about the project. Makara Beach was impacted by ex-Cyclone Gita in February this year. Residents requested Council coastal engineers provide advice to support community resilience work at Makara Beach.
Officers held a public meeting on 26 June 2018 with residents and created a working group to work on a community–led Climate Adaption Strategy. The objective of the project was to come up with recommendations to Council to create the 100 year strategy for Makara Beach. Six workshops will be conducted with the working group between August 7, 2018 and November 20, 2018. Jacqui Hastie or Mike Mendonca will provide the Board with regular updates.

- 2.1 Roading/Traffic Update Steve Wright, Team Leader Networks Steve Wright provided an update on current roading issues. The land acquisition discussion arose during this update.
- 2.5 Report from our New Emergency Management Adviser Chris Moore Chris Moore was invited by the Chair to present next and to update the Board on Civil Defense and Emergency Management plans for Ohariu and Makara. Chris provided information for the Board and a copy of this information is attached.
