LAND ACQUISITION - OHARIU

Purpose

1. This report asks the Makara/Ohariu Community Board to endorse and provide feedback on the proposal to acquire approximately 57m² of land from the owners of 15 Rifle Range Road, Ohariu for road purposes (the Land). The Board's endorsement and comments, if any, will be included in the Council Officers report to the Strategy and Policy Committee (SPC), which will consider this matter in a future meeting.

Summary

- 2. The proposal relates to the acquisition of approximately 57m² of land from the owners (the Owners) of 15 Rifle Range Road, Ohariu for road purposes.
- 3. A slip on the stream bank of Ohariu Valley Road in April 2020 required temporary retaining and stability measures to be put in place to support the road carriageway while a more permanent solution was sought.
- 4. Acquisition of the Land is required to legalise the area as road following the completion of the permanent retaining wall.

Recommendation/s

That the Makara/Ohariu Community Board:

- 1. Receives the information.
- 2. Endorses the land acquisition proposal to be considered by the Strategy and Policy Committee at a future meeting, and provide feedback if necessary.

Background

- 5. The Land is currently part of 15 Rifle Range Road, Ohariu, which is legally described as Lot 2 DP 464100, and held of ROT 615797. Refer to Attachment 1 showing the property outlined in red.
- 6. A slip occurred on the stream bank of the Ohariu Valley Road frontage of 15 Rifle Range Road in April 2020. Temporary remediation measures were put in place in the proposed acquisition area. Refer to Attachment 2 showing the slipped bank and the temporary retaining works.
- 7. Aecom have provided a Land Requirement Plan and a concept drawing for the permanent retaining works. Refer to Attachment 3 for the concept drawing.

Discussion

- 8. The acquisition, by agreement, and road legalisation is provided for under the Public Works Act 1981 (PWA).
- 9. Council will be responsible for all costs relating to this acquisition, including the Owners fair and reasonable legal costs.
- 10. Council officers have commenced discussion with the Owners regarding the proposal and hope to reach agreement within the coming weeks.

11. Report to the Strategy and Policy Committee and the appropriate following full Council meeting.





Discussion

2. The current consultations and engagements are as follows:

City Wide consultation:

a. Cemeteries Management Plan Review

The Council is reviewing the strategic and management plan for Mākara, Karori and Tawa cemeteries to ensure it can meet the short and long-term needs of our growing city.

Under the Burials and Cremations Act, Wellington City Council has statutory responsibilities and functions to provide for burials and manage cemeteries.

There are a number of issues which the Council needs to start thinking about now, so we are prepared for the future.

Karori Cemetery is almost at full capacity, and Mākara Cemetery is predicted to reach capacity for ash and burial interments between 2038 and 2047.

Demand for cemetery services and the way we use our cemeteries as open spaces is changing as our community diversifies. The Council needs to understand what services and facilities people would like to see at our cemeteries.

Heritage protection at Karori and Tawa Cemeteries is another issue. Both date back to colonial times and have significant historic value.

The Council is currently undertaking an informal engagement with key stakeholders and the wider community on how cemeteries are used and ideas for the future.

This will inform the development of a draft plan, which will go out for formal consultation in October/November 2020.

The final plan is expected to be completed in early 2021.

The informal engagement is open until **5pm Monday 31 July 2020**.

b. Future of the Central Library consultation

The Central Library has been a vital part of our vibrant inner city for decades. The building itself isn't safe to use. There are several ways to make it safe for people to be in, which also brings new possibilities in using the space. This is our oncein-a-lifetime opportunity to set up the central library to continue to support Wellington's diverse communities for at least the next 50 years.

The Council have developed a Statement of Proposal (SOP) outlining the issues with the building, the practicable options available and the factors they were assessed against to help make a decision.

What are the options being proposed?

The Statement of Proposal outlines five options for retaining a central library service in Te Ngākau Civic Precinct.

- •Option A Low-level remediation
- •Option B Mid-level remediation
- •Option C High-level remediation (preferred option)
- •Option D New build on same site
- •Option E New build on another Te Ngākau Civic Precinct site

The Statement of Proposal also includes options which were discarded, with the reasons why.

Why does the proposal suggest modernising the library?

While the priority is on re-establishing a Central Library, the Council also is responsible for ensuring the new service can meet the needs of Wellington's future generations. While providing access to books and other physical and digital collections will continue to be a core service, the Council can also offer people access new technologies, spaces and services which support life-long learning, connection and community.

How were the five proposed options decided and others discarded?

Each of the options were assessed against a range of factors. They included the building's resilience and safety; how it could support a modern library service over the next 50 or more years; the costs and timeframes; how it connects and enlivens Te Ngākau Civic Precinct and how it may affect the environment.
