TAWA COMMUNITY BOARD COMMUNITY PLAN

1. Purpose of report

To propose a process for developing a Tawa Community Board Plan for the 2013 to 2015 triennium.

2. Executive summary

The purpose of the Plan is to provide the newly elected Community Board with a set of goals and actions, consistent with its role and Council's strategic priorities, to pursue over the course of its term.

It is proposed that ownership of the development and implementation of the Plan resides with the Community Board itself. In the proposed approach, officers will provide information and facilitate discussions. Officers will also compile the resulting information and prepare a draft plan, in consultation with the Chair, for approval by the Board.

3. Recommendations

Officers recommend that the Tawa Community Board:

- 1. Receive the information.
- 2. Note the profile information based on 2006 Census data attached, and that an updated profile based on 2013 data will be presented at a later date.
- 3. Consider the proposed process for developing a Tawa Community Board Plan 2013-15.
- 4. Agree a final process for developing the plan.

4. Background

The Tawa Community Board first developed its own Community Board Plan for the 2004-07 triennium, and then developed one again for the 2010-13 triennium. These plans outlined the role of the Community Board, how it intended to connect with its community and other key stakeholders, priorities for the Board to focus on, and a three year work programme.

This paper outlines a process for developing a Tawa Community Board Plan for the 2013-15 triennium.

5. Discussion

The following process is proposed for developing a Community Plan for the Tawa Community Board:

Activity	Description	Timing
Community profile and forecast	Officers will pull together up-to-date demographic information about the Tawa community. The information will assist the Community Board in understanding the role and function of Tawa within the wider Wellington City, the make-up of the community, and how it will likely change.	Once 2013 Census profile updated
	(Initial profile based on 2006 Census data and forecast for Tawa attached as appendix 1)	
Community walk/drive-about	Community Board members will go on a tour of the area to stimulate discussions, and enable members to share their views about Tawa. If requested, Council officers could be available to provide information on topics or services of particular interest.	February 2014
Community Board workshop	Officers will facilitate a workshop for Community Board members to identify Tawa's strengths, weaknesses, opportunities and threats (SWOT). These will then inform a process to identify issues, agree priorities and develop a potential work programme.	February 2014
Draft plan	Officers will take the information gathered at the walk-about and workshop and prepare a draft plan for consideration.	March 2014
	Officers will liaise with the Chair of the Tawa Community Board before finalising the draft plan.	
Consider and adopt draft plan	The Community Board will consider the draft plan, and adopt it with any agreed changes.	March 2014
