# Tawa Community Board Submission Help us shape the 2016/17 Annual Plan – 05 February 2016

### INTRODUCTION

The Tawa Community Board is a Community Board under the Local Government Act and Wellington City Council, with elected members representing the northern suburbs of Wellington City comprising Tawa, Takapu Valley and Grenada North.

We welcome the opportunity to provide input ideas to help Wellington City Council shape its forthcoming 2016/17 Annual Plan.

We do not wish to make an oral submission and discuss our ideas with Councillors at a proposed panel hearing?

### Tawa Background:

Tawa residents exhibit a strong sense of community, shown by the many community based organisations and recreation activities. This strong sense of community and neighbourhood engagement is also shown through Tawa having the No. 1 ranking spot in NZ for community membership of the neighbourly.co.nz community engagement web site.

Over time Tawa has seen the development of big-box retail developments to the north and south of Tawa with corresponding benign neglect of the Tawa Town Centre. As a consequence the Tawa Town Centre has suffered with its ability to compete for attention of the discretionary \$ spend of residents to achieve their purchases given the wider one-stop opportunities elsewhere.

The current WCC Long Term Plan contains some funding to redevelop the Town Centre, which we see as the first step in a longer-term strategy to redevelop and revitalise the Centre to become the focus for local residents. This will then in turn halt the current downward trends; make the Centre more attractive and viable for prospective retailers and a village centre for Tawa suburb that local residents are proud.

The Medium Density Housing Plan for Tawa indicated that Tawa is an area of Wellington forecast to have a growing population base and needs facilities to be kept up-to-date to attract and support that population growth.

The Tawa Community Board requests that the Annual Plan increase the value of the Parks and Reserves operations budget to allow a higher level of service be provided for the maintenance of parks and reserves and road reserves, and in particular in support for requests for help from local neighbourhood community groups endeavouring to improve the value of their local neighbourhood green areas.

Greater support for actioning Implementation Plans.

Over the years a lot of hours is spent in public consultations and in the public making submissions on strategy plans, resulting in the Council producing numerous Strategy Plans and Management Plans and associated Implementation Plans; e.g. Our Natural Capital Plan. But the Annual Plan process doesn't seem to provide any means of providing accountability to Councillors to allow an assessment on progress with the actions of an agreed Implementation Plan to be reported. Nor does there seem to be an opportunity for Councillors to reconfirm the priorities for actions of an agreed Implementation Plan to be funded for completion in the coming years Annual Plan.

The Tawa Community Board recommends that as a matter of governance that the Councillors are given the opportunity to review the proposed Implementation Plan actions that are to be funded from the proposed Annual Plan, and to reconfirm the priorities set by officers and/or available funding levels.
