TAWA LIBRARY, TAWA COMMUNITY CENTRE AND LINDEN SOCIAL CENTRE QUARTERLY REPORT

Purpose

 To provide the Tawa Community Board with an update on the activities of the Mervyn Kemp Library, Tawa Community Centre and Linden Social Centre.

Summary

2. Mervyn Kemp Library offers circulation, information, outreach, class visits, preschool story times, holiday programmes and Baby Rock & Rhyme sessions.

Discussion

3. **Health and Safety** - The library was evacuated on February 19 after a light fitting fused, causing a smoke build up. The fire brigade attended and the light fitting was replaced. There were no injuries.

Programmes and Events

Child and Youth Programming –

- **Baby Rock & Rhyme** this is held every Friday morning at 9.30am and is aimed at babies aged 0-2 years. Weekly attendance has grown from around 30 people to around 55.
- **Holiday programme** The Summer Reading Challenge saw 11 Tawa children receive prizes. The upcoming April school holiday programme will be *Make, Create and Innovate* a hands-on showcase of digital resources and coding tools.
- **Pre-school story time** held every Monday morning at 10.30am and aimed at children aged 2-5 years. Total attendance for the quarter was 312.
- **Preschool Kapa Haka** this is a new programme, implemented as part of the Deputy-Mayor's drive to grow Te Reo programming across the city. It is community run, with library support.
- Let's Go Lego—a new monthly afterschool session that is library run. This has been well attended, with approximately 40 children at both sessions

<u>@ Six Programming</u> – community-led programming occurs each Thursday evening from 6pm. Current programming includes sessions on writing, knitting, genealogy and a community story time. The February 8th evening featured stories being read by Northern Ward Councillors, with 36 attendees.

<u>Tea & Tales</u> – the monthly book club is run on the first Tuesday of every month at 10.30am. An average attendance of 8 people at each session. Staff are visiting groups/clubs in the area to promote these sessions.

<u>IDEAs Programming</u> – this programme is run collaboratively by the library and the Tawa IDEAs group provides weekly numeracy and literacy sessions for adults with an intellectual disability. February marked the one year anniversary of this programme

<u>iPad Borrowing Programme</u> – six iPads are now available for clients to lend from the Tawa library at a cost of \$5 for three weeks, half price for Community Card holders.

<u>Home-school support</u>— advertising is planned to target local home school families with a view to restarting this programme. The group has paused, as a large family who were attending have moved out of the area.

<u>U3A Sessions</u> —three U3A sessions are now held monthly in the library: Writing, Book Club and Ukulele.

<u>Stepping Up</u> —new monthly digital training courses for customers, run in conjunction with the 2020 Trust. These are free for customers and are targeted at customers with a limited digital skillset.

6. Other business

- Construction has begun on the Johnsonville Hub. The new library is on track for a December 2019 opening.
- Wi-Fi has been improved within the library. The signal is now stronger and able to be accessed in all parts of the library. This work was completed by WCC and Dimension Data.

7. Community Centres

• Investigation has begun on implementing a new heat control system across Tawa Community Centre. This will lead to greater user control of

temperatures during out-of-hours bookings, as well as improving airflow in the hall.

- Internet charges have been removed at all northern community centres to remove access barriers for centre users.
- Three new groups have been added in this quarter: a glee club for 4-6 year olds, an evening yoga class and a Zumba class.
- Two church groups have increased bookings at Linden.
- New health workshops have been added to Tawa: Embrace your hear, WellMe, Explore Specialist Group, Arthritis NZ and Sport Wellington Green Prescription.
- A two day communication workshop for Secondary Teachers was held at Tawa.
- Wellington Timebank held a roadshow at Tawa.
- Friends of Tawa Bush Reserve held their AGM at Tawa.
- Occupancy this quarter: Tawa 33.37%; Linden 42.65%
