1 Meeting Conduct

1.1 Apologies

The Mayor noted that this is the first meeting of the Council following the formation of the 2014 Government and that she looked forward to working with the Government and the local representatives of all parties. The Mayor also thanked Deputy Mayor Justin Lester for representing her and Wellington City Council at the State Opening of Parliament 2014.

The Mayor acknowledged the two Wellington City Council teams that were highly commended when the International Association of Public Participation named the best in Australasia at its Core Values awards event in Sydney.

The Council's City Housing unit received a Highly Commended award in the Infrastructure category for the \$400million Housing Upgrade Programme and the Town Belt Planning team was Highly Commended in the Environment category.

The Mayor advised the meeting of a change to the order of business, with the public excluded item 5.1 to be taken first.

1.3 APW Awards

The Mayor presented two Absolutely Positively Wellington Awards:

William 'Bill' Rawiri

"It is my pleasure to present an Absolutely Positively Wellingtonian Award to Bill Rawiri for his services to Wellington.

Bill is leaving Wellington shortly to return to his family in Northland, but he will be remembered for his dedication to Ngā Hau e Whā o Paparārangi Marae.

He is joint chairman of the Marae, which he has guided through many changes and developments over the years, such as coordinating the volunteer teams that restored the surrounding native flora and fauna.

Then during the Christchurch earthquakes, Bill and his Marae whānau welcomed 42 people from all walks of life and different ethnicities to stay at the Marae.

The evacuees arrived without food, clothing or supplies and were provided with these essential material supplies as well as invaluable emotional support and compassion.

Earlier this year Bill was an avid supporter and coordinator of Neighbours Day in Newlands, which was co-hosted at the Marae and was very successful. He also supported building the college kapa haka movement in the northern part of the city.

All of this is in addition to running his successful business, Māori Arts and Crafts, on Wellington's waterfront.

Bill Rawiri is an outstanding, generous and compassionate Wellingtonian whom we are proud to welcome here today. On behalf of the Council, I'd like to thank Bill and declare him an Absolutely Positively Wellingtonian.
