#### 1. 2 Announcements by the Mayor

#### **Tattoo Broadsword**

As we all know, the Capital played host to the Edinburgh Tattoo over four magnificent evenings, which concluded Sunday night.

The 2016 Royal Edinburgh Military Tattoo made history as the biggest crowd puller of any show staged in the capital, with 82,000 tickets sold across the four nights.

Just as Wellington audiences were enthralled by the Tattoo, our guests were equally delighted with their experiences in the Capital.

Major General David Allfrey from the Edinburgh Tattoo said that 'the people of Wellington have been so welcoming and considerate at every turn. It has been the talk of their whole team and for many of them, the sound of 21,000 people humming Pokarekare Ana in tune with Maori vocalists and the Bands will be the abiding memory of the Tour.

In recognition of their wonderful time here in Wellington they have gifted us this ceremonial broadsword.

This is an extraordinary sword. Each year at the Tattoo in Edinburgh a Scottish Officer's Broadsword is awarded to the contingent to have contributed the most to the Tattoo experience, as voted by the performers.

The sword is much coveted and the winner is announced in front of Edinburgh Castle before the March Off at the close of the last performance of the summer.

#### 1.3 APW Awards

#### Citation for Bill Gosden

It is my pleasure to present an Absolutely Positively Wellingtonian award to Bill Gosden MNZM for his work with the New Zealand International Film Festival.

Bill is currently the Festival Director, having joined the team in 1979 and being appointed the Federation's Programme Director in 1980.

Bill's busy team coordinate a programme of films which are shown at Wellington and Auckland, and then at other New Zealand centres. The Festival has brought wonderful films to the country from all over the world.

In Wellington last year, the Festival sold more than 73,000 tickets during the 17-day event. There were more than 450 screenings of more than 150 new feature films in eight Wellington venues.

Wellington is widely regarded as the cultural capital, and events like the New Zealand International Film Festival, which Bill and his team pour their hearts and souls into, contribute hugely to our reputation.

Previously Bill has worked as a programme adviser to the International Film Festival Rotterdam and curated programmes of New Zealand film in Australia and Brazil.

On behalf of the Wellington City Council, I'd like to thank Bill and declare him an Absolutely Positively Wellingtonian.

### Citation for Robin and John White (joint award)

It is my pleasure to present an Absolutely Positively Wellingtonian Award to Robin and John White for their work in the Ngaio community.

Robin White joined the Ngaio Crofton Downs Residents' Association committee in 2002, becoming Secretary in 2009 and President in 2014. She has also been a leader of the Makererua St Reserve Care Group. Due to illness, Robin has had to step back from her Residents' Association duties so John has stepped up and joined the committee. He is the current Secretary.

Robin and John are often described as pillars of the Ngaio community. Robin has been advocating for the community and its natural environment for more than a decade. The Whites have contributed to making improvements to Cummings Park, creating a predator free environment for our wildlife, and making their community safe and vibrant.

Recently, Robin's passion for the natural environment resulted in her and John working with Council on the kākā-cam project (nicknamed the Kākā-dashian project!), an initiative to protect a nest of kākā chicks within Makererua Reserve and live stream their progress. This stream was viewed nearly 65,000 times, as far abroad as Russia and the United States.

To help the kākā survive, Robin and John motivated the local community to keep their cats indoors and their dogs on leashes, and coordinated the locals to keep watch over the fledglings until they were safe. The end result was that three kākā chicks fledged in the unfenced wild, the first time for over a century in Wellington.

Robin and John have shown great community leadership, an ability to mobilise and activate their community, and they have always taken a team-orientated approach.

On behalf of the Wellington City Council, I'd like to thank Robin and John, and declare then Absolutely Positively Wellingtonians.
