Matters Arising

- Temporary works, temporary ramps Lisa confirmed she has prepared a draft and is awaiting input from AAG members
- Events Team Angela confirmed her sub group will write a 1 page best practice on events guide, to present at next meeting
- Safe and Sustainable transport reference group a representative from AAG to be appointed at next meeting

4. Housing

Discussion

- Housing are keen to work with AAG and develop a relationship
- The AAG will be consulted at the commencement of each project
- The City Housing guidelines are a set of recommendations but they are not 'rules' for each of the projects
- Braille for lifts will be provided when it can be and in all new builds. AAG suggested it should be included in all modernisations
- AAG recommended consideration be given to the needs of the deaf and hearing impaired, particularly in entrance ways, and fire alarms
- The version 1 draft will be presented in August. It is currently in its last consultation round but will remain a living document

Action

5. Central City Framework Update

Discussion

Opera House Lane

- AAG recommend the word 'accessible' is included as a part of the vision statement
- Planned for completion early March 2013
- Details will be provided to the AAG as they are confirmed through the project planning

Victoria Street

• Outline given, longer term project, so more details at a later time

Parliament surrounds

• Outline given, more details to follow

Clyde Quay

- Planned for completion before December 2012
- Improving access to Oriental Parade, water level access and to make it more available to the public

Action

- Lisa will arrange for an opportunity for the sub-group to consult each project
- Lisa will talk with Lucie Derosiers about how to capture accessibility guidance into the 'public space design manual' to ensure it is considered in all projects

6. Lower Cuba Street Upgrade

Discussion

• AAG raised a number of concerns about the recent lower Cuba Street upgrade. They include, but are not limited to:

- surrounds of the trees as a safety and health hazard,
- depth from footpath to the surrounds is a concern,
- drainage is poor in parts,
- at both ends of the street it is unclear where motorists should stop and when pedestrians should cross,
- concrete blocks protruding into street are a safety hazard and unlikely to be used for what they were intended,
- mobility parks reduced to 1 and as placed are a safety hazard to a user of the park,
- congestion of cars and pedestrians with taxis, loading zones and passengers

Action

• Lisa will set up a meeting to enable AAG members (Kendall, Alan and Jason) to talk with Anna. Ex-AAG member Thomas Bryan to be included. Suggestion a walk around is needed to show the concerns.

- An excellent accessible version of the Long term plan summary has been created. At this stage there is no intention to lodge the full document in accessible format. Ioana will question the reasons why and recommend in accordance with the Accessibility Action plan, Council should lead the way and make the entire document accessible
