Presentation - Melanie Thornton - WRS

Melanie Thornton – Project Leader Wellington Regional Strategy presented on the Wellington Regional Strategy Indicators with reference to genuine progress indicators which is a process that accounts for the value of natural resources.

Questions asked included:

- How far back the data collection went answer 2001 census data
- What about indicator variance in other areas? <u>answer</u> data sets should be comparable for indices of change
- What were the criteria for the WRS indicator selection? The Department of Conservation monitoring indicators are coming out soon answer A formal process was undertaken for the selection of criteria.

Waste Minimisation Act Implications - Mike Mendonca

Mike Mendonca spoke about the Waste Minimisation Act and the opportunities availed to Council via the Waste Levy provisions. There was round table discussion regarding possible priority products that could receive support:

- a) Contestable fund for electronics
- b) CFL's disposing of them mercury disposal
- c) Glass recycling glass as a material to make tiles
- d) Venture Capital how to use waste products in art/crafts and returning industrial waste to raw products
- e) Life cycle analysis manufacturing with a view of recycling component parts. Education about the habits of consumption
