4. Previous minutes and matters arising

Built environment

WCC decisions regarding the Kilbirnie Town Centre Plan and Thorndon heritage zoning were noted.

Community facilities

A question was raised about whether YC had give sufficiently youth-oriented advice to WCC regarding leases for community facilities and whether YC needs to give youth-oriented advice regarding the redevelopment of the Johnsonville Library.

Emergency Management

The possibility of submitting to the Canterbury Earthquake Royal Commission was raised.

A new management plan for the Oruaiti/Point Dorset Reserve has been approved. It is a first because the reserve will be jointly managed by the City Council and mana whenua - Taranaki Whānui ki Te Upoko o Te Ika.

Social

The possibility of submitting on the Government's green paper on vulnerable children was raised. Submissions close 28 February 2012.

Sports and events

The success of the Rugby World Cup and of the associated events was noted.

Transport

It was noted that the 99 bicycles gifted to Wellington by the city of Beijing had arrived.

YC discussed the possibility of submitting on WCC's current traffic and parking restrictions consultation. After canvassing Miramar parking issues, especially in relation to the Roxy Cinema, it was decided that YC did not have time to make a collective submission but that interested members should make submissions as individuals and let people in their networks know about the consultation.

It was noted that WCC is making good progress on the shared path/cycleway in Tawa.
