## **YC Annual Report**

Members broke into small groups and commented on sessions of a draft Annual Report. The working group will review the comments and intended to present a final draft at the Youth Council meeting on 13 November for ratification. The Annual Report can flag issues to do with the administration of the YC, the work of the group and future intentions.

There was discussion about a Terms of Reference review. WCC is likely to review the YC's Terms of Reference shortly as:

- minor technical changes are required (e.g. YC can longer report to the Strategy and Policy Committee as this committee no longer exists)
- the Terms of Reference for the Accessibility Advisory Group require a review at the beginning the each triennium and WCC generally reviews all the groups at the same time.

Youth Council agreed to devote a full meeting to discussing issues and determining recommendations for the Terms of Reference review.

#### **End-of-Year event**

The YC decided that Bing, Jack and Simon should organise an end-of-year function to celebrate the year's achievements.

#### **Public Transport Spine Study Submission**

The YC has received excellent feedback about its Public Transport Spine Study submission.

### **Inauguration ceremony**

Brittany will accompany Jack to the function after the Councillor Inauguration Ceremony.

#### **Delegation from the Indonesian Ministry of Youth and Sport**

The Youth Council decided to accept an invitation to meet with officials from the Indonesian Ministry of Youth and Sport on Friday 8 November at Wellington City Council.

## **Drinking Fountains update**

Sections from the Terms of Reference were read out in response to issues raise in a Drinking Fountains discussion thread on Loomio. These included:

- The Chair will work with Council officers to compile meeting agenda
- The Chair will be the spokesperson for the Youth Council and represent the views and recommendations of the group
- The Council officer will be responsible for the administration, support and promotion of the group
- The Council officer will work across Council business units to ensure youth are considered in the development and implementation of policy, strategy, planning and service delivery in the city
- The Council Officer will enable other business units to develop effective working and consultation relationships and practices with young people and Wellington's Youth organisations.

In response to a query about how YC agrees things, members were reminded that YC decisions require quorum plus one at a meeting. Loomio can be use to ratify submissions.

The YC's Terms of Reference set out two main activities for the YC: providing advice and youth outreach. The elections website is an example of an outreach project where the working group got approval for the project plan from YC and then provided regular updates and opportunities for YC input.

When advising the WCC, the YC agrees its submission. WCC action occurs when the

Council or the appropriate Council committee directs the Chief Executive Officer and the CEO then directs Council officers.

The meeting closed at 5.15pm. Most members then went to the Michael Fowler Centre for the Councillor Inauguration Ceremony.
