 - Impact of that advice.
 - o What has helped or hindered that impact?
 - Māori perspectives
 - How well does the model enable Māori perspectives, in addition to, not instead of, the function provided by the Council's arrangements with Iwi?
 - Improvement/future focus
 - How can the Advisory Group Model be improved to more effectively and efficiently achieve outcomes/impacts?
