# SOCIAL AND RECREATION FUND

# **Purpose**

 This report provides recommendations for allocation of funding through the Social and Recreation Fund for three organisations (from 1 July 2018).

# **Summary**

- 2. The Council provides grants to assist community groups and organisations to undertake projects that meet community needs. Grants are also a mechanism for achieving the Council's objectives and strategic priorities, especially those priorities that rely on community organisations carrying out specific activities.
- 3. A range of organisations are funded through multi-year contracts. Three organisations deliver outcomes relating to homelessness and transitional housing and have funding contracts with three-year contracts ending 30 June 2018.

# Recommendation/s

That the Grants Subcommittee:

- 2. Agrees to the allocation of funding through the Social and Recreation Fund (from 1 July 2018), as listed below, subject to Social and Recreation funding being available through the 2018/2028 Long-Term Plan.

# **Background**

- 4. Grants and funding are included in the Annual Plan to provide an appropriate mechanism for the Council to respond to community groups and organisations that are undertaking projects that:
  - Meet a need identified by the community.
  - Align with council's strategic goals and community outcomes.
  - Rely to some extent on participation and engagement by community organisations.
- 5. Organisations and projects are funded through both contracts and contestable grants pools. The contestable pools provide grants that are discretionary, short term and generally project based in nature. The Council also enters into multi-year contracts when it has an interest in ensuring particular activities occur that contribute to Council's strategies or policies.
- 6. The Strategy and Policy Committee agreed (in April 2005) to a re-configured grants framework in which organisations whose activities directly contribute to Council's strategic or policy goals would be funded through a detailed contractual arrangement before a review of the funding and outcomes achieved at the end of the contract (generally three years).
- 7. These organisations and the specific needs they meet are critical to Wellington, contributing to Wellington's sense of place and are part of the city's infrastructure. Organisations that are funded through three year contracts are considered sustainable in the long term but need some financial support and some certainty of funding. Organisations funded by the Council through multi-year contracts need to meet the relevant fund criteria of the Social and Recreation Fund.

### Discussion

### Te Whakamura Ai Te Ahi

- 8. Te Whakamura Ai Te Ahi is a collaboration of Downtown Community Ministry and Ngati Kāhungunu ki Pōneke. The collaboration was funded through a three year contract (2015- 2018) to deliver services aligning to Te Mahana Ending Homelessness.
- 9. The contracted amount for Te Whakamura Ai Te Ahi was \$395,759 p.a., with \$141,131 being held by Downtown Community Ministry and \$254,426 by Ngati Kāhungunu ki Pōneke Social Services Inc.
- 10. We are recommending a two-month extension of the existing contract for these two organisations to allow us to move to a Housing First model aligning our funding with that of our partners. This will ensure complimentary and enhanced services developed and delivered for Wellington.
- 11. We are recommending a transitional grant for a two-month extension of the existing contract. For Downtown Community Ministry this amounts to \$23,522 and for Ngati Kāhungunu ki Pōneke the transitional amount is \$42,438.

### **Wellington Night Shelter Trust**

- 12. The Wellington Night Shelter currently offers hostel and emergency shelter for men who are homeless.
- 13. The Trust is funded through a three year contract (2015/18) with a level of funding of \$95,000 p.a. In 2017/18 this was increased to \$152,389 (a one off).

- 14. The Trust is developing a model that will include transitional housing and to allow time to discuss with other funding partners we are recommending and extension of two months of the current contract.
- 15. We are recommending a transitional grant of \$25,398 for a two-month extension of the existing contract for The Wellington Night Shelter
