2. General Business

APPROVAL OF A NAME FOR A PRIVATE RIGHT OF WAY OFF HOUGHTON BAY ROAD

Purpose

1. The purpose of this report is to seek approval to name the private right of way off Houghton Bay road, as shown on the F Plan 3076.

Summary

2. This is a proposal to name the private right of way which gives access to the properties currently numbered 73A through to 75F Houghton Bay Road.

Recommendations

That the Regulatory Processes Committee:

- 1. Receive the information.
- 2. Agree to give approval for the name Pari Tai Way to be allocated to the private right of way as shown on Plan F 3076 (Appendix 1).

Background

3. The properties from number 73A to 75F Houghton Bay Road are accessed via a private right-of-way off Houghton Bay Road. Due to ongoing subdivisions and lack of spare numbers, alpha numeric numbers off Houghton Bay Road were assigned to the properties prior to the adoption of the Australasian Addressing Standards in 2012. The Standard state: "Alpha Suffixes shall not extend beyond letter E". This means that only the letters A to E can be used for alpha-numeric numbers. The letter F is not able to be used according to the Standards. Consequently these addresses need to be reviewed.

Discussion

- 4. There have been ongoing subdivisions in the area. Numbers 73C & 73D Houghton Bay Road have recently been further subdivided into four lots. The titles have been issued for the newly created land parcels and plans have been lodged with the Council to build new homes.
- 5. There are no spare street numbers available to allocate to the houses being built on these additional land parcels. Naming the right of way will also give us an opportunity to allocate unique street addresses to the properties currently using the alpha-numeric numbers 73A through to 75F Houghton Bay Road.
- 6. We have been in consultation with the Houghton Valley Progressive Assocaition for suggestions on naming of this private right of way. They proposed the name Williamson Way but this name is being used in Karori.

- 7. We have also been in consultation with local iwi and they have suggested the name *Pari Tai*. Iwi advised that "*the name Pari Tai speaks of a point on a cliff overlooking a tidal area*". This name is not historical but is about connection to place.
- 8. The naming of the right of way affects twelve property owners. All affected property owners have been consulted on the proposal. Ten of these will have to change their property address and two can retain a Houghton Bay Road address.
- 9. Out of the ten property owners who will have new addresses, nine owners either support, or are unopposed, to the proposed name Pari Tai Way. One owner has not replied to our letters. One other property owner does not support the proposed name. This owner would "like a name that gives hope to people when they read it" and suggested the following names in order of preference:
 - Gods Way
 - Supernatural Way
 - Glorious Way

The owner wanted the above names to be considered by the other nine owners. These owners have been contacted again and the majority still support the name Pari Tai Way.

Recommended Names

10. Council officers recommend Pari Tai Way to be approved for the private right of way. The majority of the property owners affected support the name and the name is not being used in the Wellington region.

SUPPORTING INFORMATION

Consultation and Engagement

Consultation on the proposed name has taken place with the owners/residents affected by the naming of the right of way. The majority of the owners support the name Pari Tai Way.

The name has been checked for duplication, similarity and suitability with the Wellington Regional Council. They have no objection to the use of the proposed name in the Wellington region.

Consultation with Houghton Valley Progressive Association has taken place. They posted a request for feedback on the proposal in their community newsletter and have received five positive responses.

Treaty of Waitangi considerations

Iwi were invited to make a suggestion; they suggested the name Pari Tai.

Financial implications

There are no financial implications.

Policy and legislative implications

Allocation of street names is a statutory function under section 319A of the Local Government Act 1974.

The report is consistent with the Council's Road Naming Policy.

Risks / legal

There are no obvious legal implications in this proposal.

Climate Change impact and considerations
