"The yellow notice simply advises all who choose to enter the building, that this building is earthquake prone. Under the building Act the "owner" of the building has 15 years in which to strengthen the building to at least 34% of the new building standard described in the act. It doesn't mean that it's unsafe nor that it's uninhabitable. Council has assessed at 25% of code and the engineers have identified that there could be some loss of strength in the roof structure because of its construction. In simple terms some diagonal bracing under the roof trusses could fix the issue."
