


Proposed District Plan Structure

- Structure set by National Planning Standards
- Part 1: Introduction + general provisions
- Part 2: District-wide: strategic direction, energy, infrastructure, transport, natural hazards, contaminated land, hazardous substances, historic heritage, viewshafts, indigenous biodiversity, natural character, natural landscapes, subdivision, coastal environment, earthworks, noise, signs, etc.
- Part 3 Area-based chapters: zones, precincts, development areas, designations
- Part 4 Appendices, Schedules, Design Guides

Intensification Streamlined Planning Process (ISPP) vs Standard process


- ISPP from RMA amendment Dec 2021. National Policy Statement on Urban Development intensification, "qualifying matters" (exemptions) and Medium Density Residential Standards (~60% of PDP)
- ISPP uses independent hearings panel recommendations to Council. If Council disagrees, goes to Minister for the Environment for final decision
- Rest of plan follows standard RMA process: Panel makes recommendations to Council, Council makes decisions. If submitters disagree, can appeal merit to the Environment Court
- PDP provisions gradually take effect over ODP at various stages in process complicated!





Landscapes, ridgelines, **SNAs**

- SNAs now identified on rural land and reserves
- Most vegetation removal triggers resource consent to protect the biodiversity where practicable
- Adverse effects: avoid where practicable first, then minimise, then remedy, then offset or compensation can be considered
- Outstanding Natural Features and Landscapes have highest value, then Special Amenity Landscapes, then **Ridgelines and Hilltops.**
- A matter to consider in resource consent application.
- ONFL and SAL have height and colour standards, and policy to protect/maintain the landscape characteristics

- General Rural Zone
- Neighbourhood Centre Zone
- Metropolitan Centre Zone
- General Industrial Zone
- Natural Open Space Zone
- Open Space Zone
- Sport and Active Recreation
- Special Purpose Zone


Medium Coastal Inundation

Rural Zone, Natural High Density Residential Zone Hazards

- Rural Zone similar to Operative DP
- Makara Beach and Makara Village have a precinct to allow low-density residential, and account for flooding risk
- More information on fault hazards, return periods
- Coastal inundation risk included

Historic heritage, including sites, areas of significance to Māori

- Includes rivers, bays, historic sites, statutory acknowledgments
- Mana whenua need to have spiritual/cultural values considered if features modified or buildings constructed
