 - b. Adding Oxford Street and Cambridge Street to the secondary network, connecting Tawa pool to Tawa centre.
 - c. Adding a secondary connection from Takapu Station to Jamacia Drive to connect the Grenada North development area.

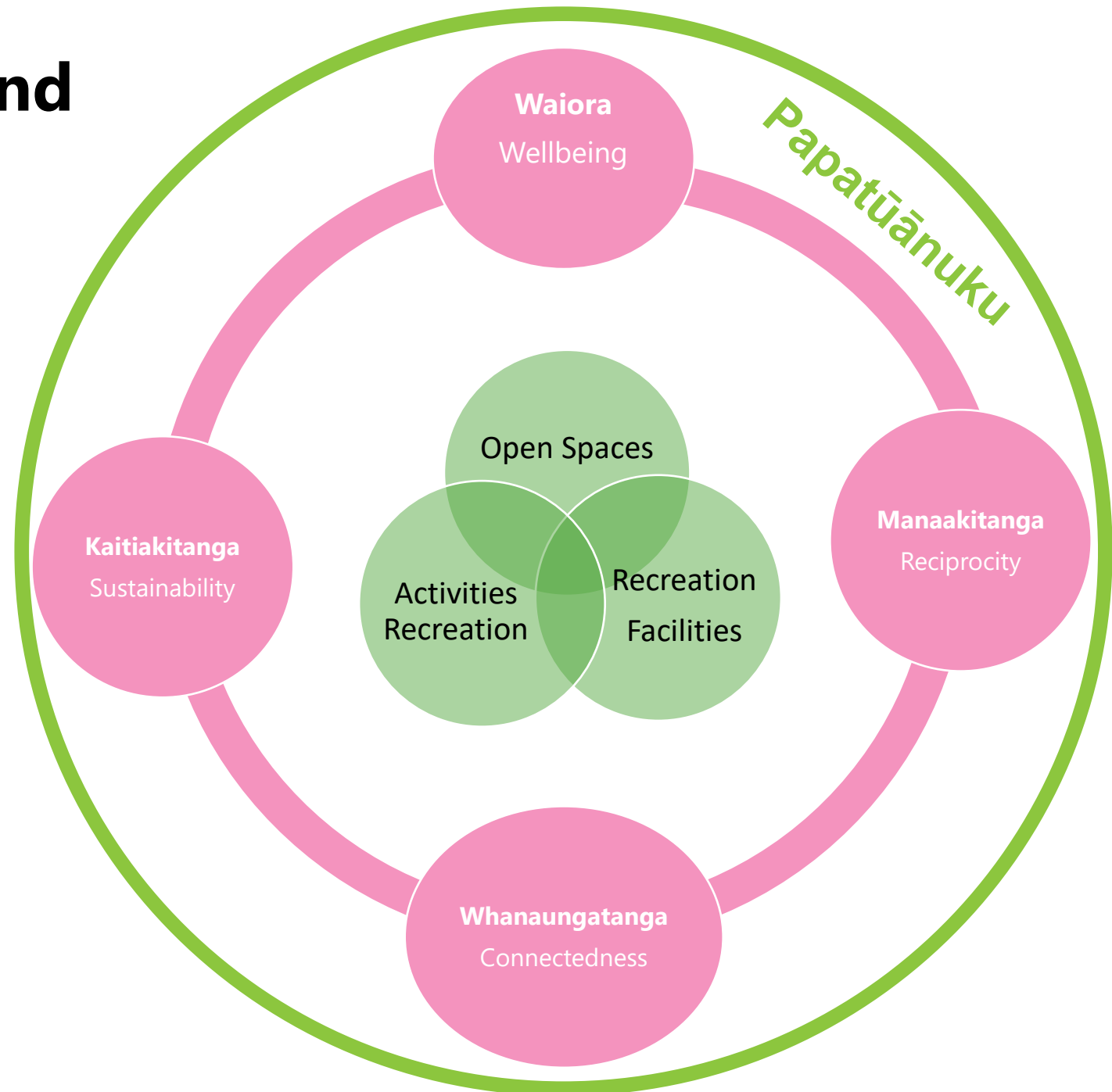

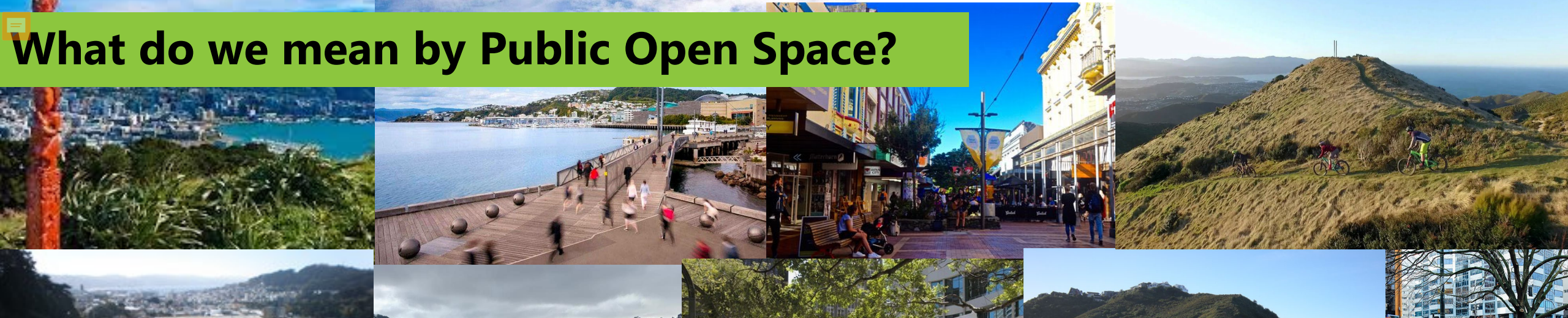


What is the Open Space and Recreation Strategy?

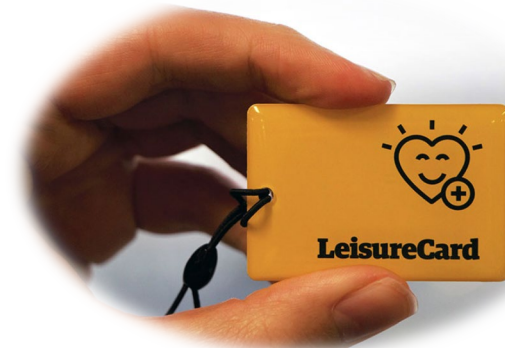

Our City Tomorrow: Spatial Plan for Wellington City



Concern about the impact of growth on open spaces

Denser housing without adequate adjacent provision of green spaces is a recipe for social disaster

What is required is recreational space close to where people actually live

Access and proximity to the natural environment is vital





CONTEXT: Key Recreation Trends



Only 23% of adults participate enough to meet physical activity guideline thresholds



Downward trend in kids being involved in teams or clubs



Inequities

People from higher deprivation areas participate in fewer sports and activities each week. Men and boys spend more time being physically active than woman and girls.

Response to changing lifestyles?

> more innovative, diverse and flexible recreation

250 parks 1# environmental security city, biodiversity growing, contributing to our quality of life

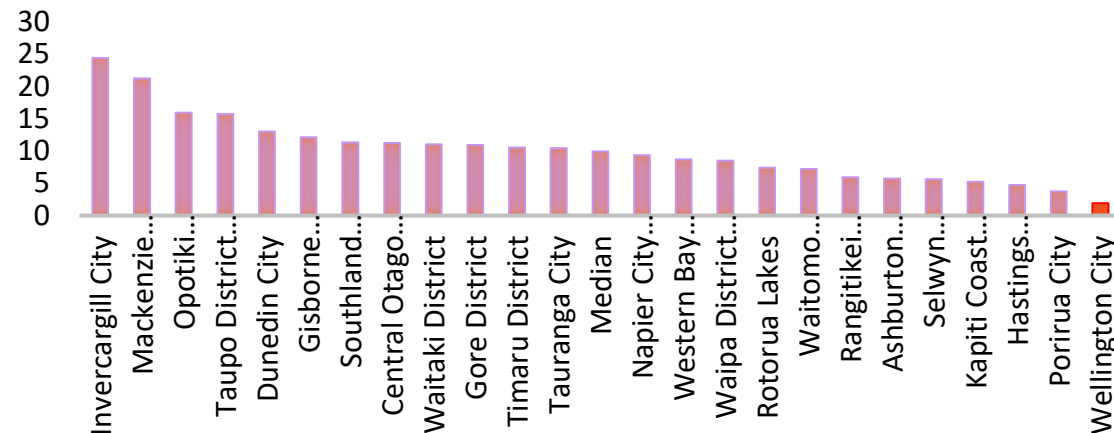


80% of people use our parks at least monthly

ACTIVELY MAINTAINED PARK SPACE PER 1,000 RESIDENTS (HA)



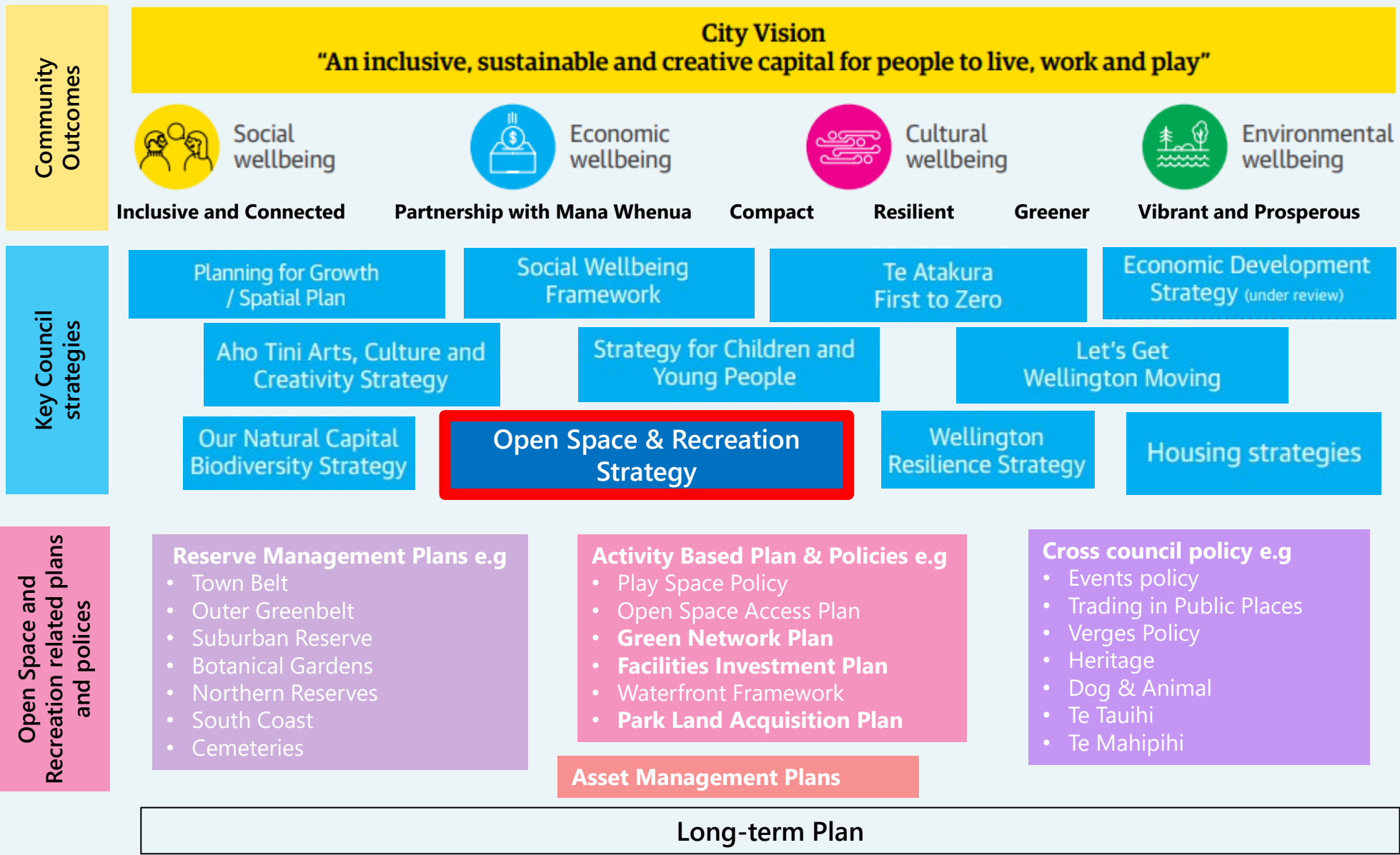
