2. General Business

ONLINE VOTING TRIAL 2016

Purpose

1. The purpose of this report is for Council to confirm its' intention to participate in the online voting trial for the 2016 local government election.

Summary

- 2. Central government has indicated their support for an online voting trial for next year's local government election.
- A Cabinet decision on which councils will be permitted to be part of the trial will be made by late September and a final decision on whether or not a trial will proceed is expected by early December.
- Local Government New Zealand (LGNZ) is seeking confirmation from interested councils to confirm their interest in order to be included in the list of participating councils to be presented to Cabinet.
- 5. Council is required to confirm its participation in the proposed online trial and allocate an additional \$100,000 to fund this.

Recommendations

That the Council:

- 1. Receive the information.
- 2. Agree to confirm Wellington City Council's interest to participate in the proposed online voting trial for 2016 local election.
- 3. Agree to allocate an additional \$100,000 to the Election budget to cover the cost of participating in the online voting trial.

Background

- 6. In May 2015 Council agreed to register its interest, subject to cost, in participating in the online voting trial proposed for the 2016 elections.
- 7. Wellington City Council uses "electionz.com" as its Electoral Officer and election service provider. Electionz.com is recognised as having specific expertise in elections management and is confident that the system they have developed meets the requirements for the trial.
- 8. Ten (10) local authorities have expressed an interest in participating in the trial using electionz.com as their election service provider. The other councils are Rotorua, Masterton, Matamata-Piako, Horowhenua, Porirua, Marlborough, Selwyn, Christchurch and Dunedin.
- Following LGNZ's initial discussions with the Minister, and now that cost estimates are available, councils are being asked to reconfirm their interest in participating in the trial. A decision regarding whether the trial will proceed is expected to be made in December 2015.

Discussion

- 10. Underpinning Wellington City's operations and aspirations is our vision of Smart Capital, a people-centred, hi-tech, progressive and ecologically-responsive place where talent wants to live. Being part of the local government online voting trial is consistent with this vision and our digital philosophy.
- 11. The capital's population size, engagement in local body and central government issues, and strong uptake of digital communications are strong attributes for a successful trial.
- 12. Our track record in adopting progressive forms of voting, such as Single Transferable Voting (STV), indicates a willingness of Wellingtonians to embrace new forms of representation.
- 13. If the 2016 trial is considered a success by the councils involved, and by central government, it is likely that all councils will be required to offer online voting in the 2019 elections.
- 14. Online voting has a number of advantages including:
 - Making voting faster and easier on any device
 - Improving the voting process for those with disabilities such as the visually impaired community and thus enable them to vote independently without assistance
 - The Wellington City Council's Youth Council is driving online voting on behalf of youth. Online voting makes it easier for them to vote, encouraging their participation, which has traditionally been low
 - Making voting easier for residents/ratepayers overseas during the election period.
 Wellington has a disproportionate large number of overseas voters
 - Reducing the number of errors on voting papers or invalid votes.
- 15. This presents an opportunity to increase our voter turnout.
- 16. The trial will be limited to a small number of councils, incorporating a mix of metro, rural and provincial councils.

Options

17. Council has the option not to participate in the 2016 online voting trial, and continue to accept postal votes as the only voting method.

Next Actions

- 18. 17 September 2015 Councils must confirm their intention to participate in the trial.
- 19. Late September 2015 Cabinet decision on which councils will be permitted to be part of the trial.
- 20. Early December 2015 Final Cabinet decision on whether or not a trial will proceed.

SUPPORTING INFORMATION

Consultation and Engagement

No consultation is required for this decision. However, a comprehensive communication plan will be developed to promote voting in the 2016 local government elections. If council chooses to participate in the online voting trial, additional communications will be used to encourage online voting.

Treaty of Waitangi considerations

No implications.

Financial implications

The total cost of the online voting trial (approx \$1.1M) will be split between the electionz.com councils participating in the trial based on the number of electors in their district. At this stage it is estimated that Wellington City Council's portion of this would be approximately \$100,000.

The cost of participating in the online voting trial is not included in existing budgets. If council agrees to participate in the online voting trial, an additional \$100,000 will need to be allocated to the election budget.

Policy and legislative implications

No implications.

Risks / legal

Central government has set a number of requirements for councils participating in the online voting trial relating to security, usability, accessibility, audit requirements. The requirements at this stage are in draft and will have to be met prior to the commencement of the trial.

Climate Change impact and considerations
