# 2.1 Arlington Redevelopment Project: Consultation Document

Proposed high level terms have now been agreed but negotiations are ongoing and subject to public consultation and final Council approval.
- 3. Notes that on 21 March 2019 the City Strategy Committee was advised that the Special Consultative Procedure would be used to seek public feedback on the proposed partnership deal to redevelop Arlington Sites One and Three.
- 4. Notes that a draft Statement of Proposal has now been prepared as a draft public consultation document (attached as Appendix 1), which includes a proposed amendment to the Long Term Plan.
- 5. Approves the attached draft consultation document (Appendix 1) and survey (Appendix 2) that will be used to seek public feedback on the proposed partnership deal to redevelop Arlington Sites One and Three.
- 6. Notes that the period for the public to provide written feedback will run from 29<sup>th</sup> April 2019 to 29<sup>th</sup> May 2019.
