#### 2. General Business

#### 2.1 Future of Karori Event Centre

#### Moved Councillor Matthews, seconded Councillor Woolf

#### Resolved

That the Council:

- 1. Receive the information.
- 2. Agree to accept the gift of the Karori Event Centre Building from the Karori Community Hall Trust on the condition it is available for a reasonable amount of community use.
- 3. Note that this gift will be the subject of a Deed of Gift detailing the terms and conditions required by both Council and the Trust. This will include appropriate

recognition for the generosity of the various funders and supporters who enabled this building to be built.

- 4. Agree to bring to an end the ground lease previously granted by Council to the Karori Community Hall Trust that permitted the building to occupy Council land.
- 5. Note that a previous resolution of Council required that the proceeds from the sale of the St Johns Hall site offset \$610k of advance funding provided by Council to the Trust towards the build of the Karori Event Centre.
- 6. Note that the Karori Community Centre (KCC) will manage the community access hours under an MOU between Footnote New Zealand Dance, Wellington City Council and KCC.
- 7. Note that as the advance to the Karori Community Hall Trust has been utilised for the construction of the building, Council does not expect this amount to be returned as the value is reflected in the building asset gifted to Council.
- 8. Note that the Karori Community Hall Trust will be repurposed so that it can be an ongoing supporter of the Karori Event Centre including completing the fundraising to allow installation of the retractable seating.
- 9. Note that officers intend to offer Footnote New Zealand Dance a lease to occupy the building with a requirement to make the unused spaces available to the community.
- 10. Agree to a capital expenditure budget increase of \$1.22m (GST excluded) for the building fit-out, noting that this will be offset by any proceeds from the sale of the St Johns site, over and above the initial \$610k already committed
- 11. Agree to increase Council's operating budget by \$95,000 (GST excluded) to fund the ongoing operational costs for this building, to be partly offset by rent from the lease(s)
- 12. Agree that both the capital expenditure and the operating expenditure outlined in this report will be included in the final 2020/21 Annual Plan Budget.
- 13. Note that officers will work with the Karori Community Hall Trust to project manage the completion of the building before it is formally gifted to Council.
- 14. Agree that future community partnership projects will only be considered where they are consistent with existing Council plans and policy and that for any future community facility proposals the following will be undertaken:
  - a. a needs assessment to determine if there is a community need
  - b. a feasibility study which looks at the business case, projected use/income/expenditure and life cycle maintenance costs etc
  - c. a funding agreement which details at what point in the project Council will release funding towards the project






