1.3 Announcements by the Mayor

The Mayor made the following announcement:

"Councillors, I want to talk to you briefly about reactivation of our Central City. A number of commentators have recently observed how quiet our Central City is, and asked what is being done to reactivate it. They have been ignoring Covid, the rules that prevented or limited many activities, and the chilling effect of fear of Covid on some of our community – but not by any stretch all. They appear to suggest Council could somehow stand against the pandemic wave like Canute against the tide.

The data clearly shows that office based downtown Wellington and Auckland as well as tourism dependent locations such as Queenstown have felt the pandemic's impact most heavily. However this worst of times is passing – and passing fast. As it does, Council is laser focused on reactivating our central city.

People are starting to come back into the city, the mood is lightening. People are starting to come together more. It was wonderful to see so many people coming together yesterday morning at the opening of Transmission Gully. Zoom is no substitute for that.

I'm going to take the opportunity to remind people of what we as a Council are doing, and I want to place on record my thanks to you, Councillors and to our officers for their work on this.

As you know Council's pandemic response package was developed with our business community and passed through Council on 24 Feb – woah to go – in just 13 days.

A range of fees for hospitality – including food and alcohol licencing charges and pavement dining licences – have been wiped for a year. We've reduced parking fees at weekends and in the evenings until June and given people longer to enjoy the city at those times.

We've established a fund to support businesses affected by the combination of Covid restrictions and the Parliamentary protest.

We, Council and Wellington NZ, are working with business, arts and events to reactivate our City through what will be a great series of events right through the rest of the year and into 2023. We are working with public and private sector leaders to encourage people to return to work in the city. Our job will be to do all we can to make this something people choose to do, because they really want to enjoy all the city has to offer and the joy of meeting again in person with colleagues, and friends. I know many of us miss face-to-face meetings with real (not Zoom) people, and those causal meetings in the office or the street are often priceless.

I also wanted to remind people of the huge investment we are making in Wellington's longer term future. We have invested heavily in infrastructure in a challenging environment.

Work on the Wellington Town Hall, Tākina, St James Theatre and the city's largest ever reservoir Omāroro are forging ahead, and we can look forward soon to sharing plans for (Te Matapihi) our Central Library shortly. We can all see the extensive private development too.

Our Poneke Promise partnership is making our entertainment district safer.

Finally I want to remind everyone that consultation is now underway on our new draft Economic Wellbeing Strategy. It is integrated and full of exciting opportunities for growth and employment. I encourage everyone to read the draft Strategy, think about it, and provide feedback. It's been tough, and the macro economic and global environment has some serious challenges, but I think we can see the light at the end of our own city tunnel and I believe the light is growing brighter every day.
