## 1 Meeting Conduct

The meeting opened at 5:00pm with a pōwhiri. Following the pōwhiri, Ngāti Pōneke gave a performance.

#### 1. 5 General Explanation

The Chief Executive provided a general explanation about the elected member's legal responsibilities under various pieces of legislation:

“As Chief Executive of the Wellington City Council, I am required to give a general explanation to elected members of certain legislation which controls the way in which the Council's business may be conducted and the laws affecting elected members.

The Local Government Official Information and Meetings Act 1987: This Act sets meeting procedures and requirements and governs the availability of information. The key principle underpinning the Act is that information should be made publicly available, unless certain specific withholding grounds apply.

Other laws affecting elected members: There are other obligations which elected members must be aware of and which are included in a range of legislation. Further information on these provisions was provided both in your briefing pack and in the verbal briefing that you attended on 20 October.”

Councillors, council officers, Members of Parliament, distinguished Wellingtonians.

To former Mayor, Andy Foster, I would like to acknowledge the 30 years of public service you gave to Wellington. That is an amazing feat that you should be very proud of. Thank you.

I would also like to acknowledge that this is the first time the inauguration of Wellington City Council has been held at Pipitea Marae. It speaks volumes about the existing relationship between Council and mana whenua, and it's a relationship I intend to nurture and grow.

It's also worth noting that I am the first wahine Māori Mayor of Wellington, and we also have our first Māori Ward councillor.

A year ago, I announced I was running for the Wellington Mayoralty. Over the last year I attended countless debates, engaged through social and mainstream media, and heard from thousands of people across all walks of life.

It was very clear that Wellingtonians wanted change. That is what I aim to deliver as I start my first term as Mayor of Wellington.

Wellington is on the cusp of exciting, transformational change. We are heading into a new era. This is change that needs to happen. Change that our communities have asked for, change that I will facilitate and lead around the council table.

We will create a city centred around people with great public transport, cycling and walking options as we head to a carbon-neutral future. I want to assist in creating thousands more homes for Wellington – particularly along the corridor from the CBD to Newtown – as we plan for a bigger, more diverse Wellington.

And I want to work with the business community so they not only flourish but also play their part in the changes that are coming. The result will be thriving, connected communities and the reinforcement of Wellington as a fabulous place to work, live, study and play.

It's moving away from being the coolest little capital to becoming a City of Impact, a city that leads the way in how positive change can be good for business as well as the planet. Key to making this happen is the incredible array of talent we have around the council table.

You all put yourselves forward because you want to serve the city. I congratulate you on your success and look forward to working with you.

Let's work together to create a unified council and make great decisions for Wellington, Wellingtonians and the future of humanity.

Being unified doesn't mean we always have to agree. It doesn't mean that there won't be heated debate. But I want to foster an environment based on trust, honesty and respect.

Let's make those our three pillars as we work together over the next three years. We deserve that, council officers deserve that and the people we have been voted in to serve – Wellingtonians – deserve that too.

I am incredibly excited and optimistic about what we can achieve together as a Council. We have a team peppered with a great mix of experience and new talent. I am one of the newbies but from what I can see, Council officers are at the top of their game. I look forward to tapping into that pool of excellence.

It was the greatest honour of my life to be elected Mayor of Wellington. But it comes with great responsibility. I will do my utmost to live up to the expectations of Wellingtonians to make things better for the city they love, and the planet they are reliant on.
