The Local Government Official Information and Meetings Act 1987: This Act sets meeting procedures and requirements and governs the availability of information. The key principle underpinning the Act is that information should be made publicly available, unless certain specific withholding grounds apply.

Other laws affecting elected members: There are other obligations which elected members must be aware of and which are included in a range of legislation, including the Local Authorities (Members' Interests) Act 1968; sections 99, 105, and 105A of the Crimes Act 1961; the Secret Commissions Act 1910; and the Financial Markets Conduct Act 2013. Further information on these provisions was provided both in your briefing pack and in the verbal briefing that you attended on 20 October."
