Hi, sorry I can't make it – am in conference with work.

I'll try and get there but won't be able to speak at my allocated time.

Please read out my bit on my behalf:

Can I say that I oppose the cycleway changes – losing all the carpark in your updated plan will not be good for business in island Bay, and not good for those people living on The Parade.

There will be problems for the elderly trying to get to the Doctors room or the shops and having to park so far away.

People will not come to the movies due to lack of parking, and the theatre is a great hub for our community – our cafes are also great meeting points – we need park spaces. I have lived in Island Bay most of my life and I certainly don't want it to become a ghost suburb. That's what will happen – we will lose the community feel.

Less parking spaces only means people will occupy the other streets off The Parade, making it hard for residents who don't have "off street" parking to park their cars.

The Council is living in Dreamland if they think Wellingtonians will give up their cars to bike around – imagine carrying all your shopping bags home on a "bike" - bloody stupid.

Please let common sense prevail and put things back to the way they were originally before the Council made a mess of Island Bay's best street.

I recommend that the cycleway gets allocated space on the footpath. There is plenty of room for pedestrians and cyclists.

Reconsider your plans.
