- Noted that Wellington City Council is providing a venue for the Human Rights commission to hold a series of workshops for community input into the a report to the United Nations on the Disability Convention. Information will come form the commission on the date

### **6. AAG member induction** (Up to 15 min each, including questions, = 60 min)

• The Building Act and Building Consents and Licensing [Manager Building (Commercial and Major Projects) – Rob Tierney]

#### Main points:

Building Act 2004, Section 118, 112, NZS 4121. Role of the Department of Building and Housing and Building Consent Authorities. A key issue is the term 'reasonable and practicable' used in the Code in reference to renovations, as this term is not defined anywhere.

Discussion: Can the financial situation of the building owner impact on a Building Consent Authority decision? Schedule 2 lists public buildings, economic/market advantage in accessible buildings. The answer is dependant on interpretation of the 'reasonable and practicable' requirement.

• The Council and the Treaty Relations (Nicky Karu)] Main points:

The Treaty Relations Unit work responds to ongoing Treaty settlements and related organisations (e.g. 2003 Wai 145, Port Nicholson Settlement Trust) through memoranda of understanding with the Council. The principles guiding relationships are: partnership, participation and protection. The mandate is set out in the Long Term Council Community Plan 2009-19. The Council needs to include engagement on the full range of Maori aspirations (The profile of the Maori population in Wellington is different than most cities.).

• How the Council works : Manager Research, Strategy, Urban Design and Heritage (Brian Hannah)]

#### Main points:

Brain shared with the group how the Council works, which included the committee structures, how decisions are made the decisions are made in Council as well as the budgeting cycle.

Council under Local Government Act 2002, the AAG can seek to influence governance and organisation of Council strategies, plans and policies.

Around \$10,000 is the trigger for any new projects requiring the full Annual Plan process.

- Mike to consider accessibility for people who are Blind (i.e. in text and by street)
  [Mike will have a look at maps for Blind people in the New Year. It might be easier
  to ask Blind people to contact us or go through the RNZFB rather than trying to
  convert maps to text.]
- Mike to report back on what, if anything, the Council can do to encourage provision
  for people with disabilities in high-rise buildings. (Council can't make building
  owners exceed the Building Act requirements. The Fire Regulations are currently
  under review (Thomas to forward information when it is available). Building owners
  / body corporates may be responsible.) [Mike will look at this more in the New Year.
  This may be more of a local arrangement and relationship rather than something we
  can legislate.]
- Ken to consider this for inclusion in the Accessibility Action Plan. [Done]
- [The Wellington Emergency Management Office had already decided to add signage to the tsunami warning vehicles (the loud speaker cars), but hadn't considered. The wording hasn't been finalised yet, but will be along the lines of 'Tsunami Warning listen to your radio or go to www.wemo.org.nz'. These would be mounted on each side of the vehicle, front and rear either magnetic signs or something else quick

and simple to attach. These will be made early in 2011. Mike and WEMO will consider whether they could also have an LED message display but even these wouldn't be foolproof. The PA/siren units are mounted on a variety of vehicle types and are a strong, rugged design. Getting LED units designed and built to withstand Wellington weather (and CitiOps staff!) would be an expensive endeavour, with uncertain outcomes. Communication via neighbours and friends is likely to be the most effective part of the mix.]

### **Receiving Emergency Alerts on Your Mobile**

Please note this system is not foolproof - it is dependent on technology - and is just one of the tools available.

You can sign up to receive WEMO alerts direct to your mobile phone and hear about any large-scale emergency in Wellington (for example, a tsunami warning).

- Text alerts are free, but sign-up costs you four texts at your standard rate.
- You will receive 3 4 test messages a year and any other message will be a real alert.
- The text alerts do not currently work on mobile phones using the 2degrees network.
- If you receive an emergency alert, forward it to your networks, or re-tweet the message if you're on Twitter.

#### Signing Up

Wait for a reply after each text sent. If you already receive tweets to your mobile phone, go to step 5.

- 1. Text the word "start" to 8987.
- 2. Reply with the word "signup".
- 3. Think of a unique username. (You won't need to remember it again, so you could use your name followed by some random characters, e.g. "Kelly495hgim".)
- 4. Reply with your chosen username. (If you are already on Twitter, use your existing username and it will ask you for your password.)
- 5. Send / Reply "follow wemonz" to 8987.
