Items

3. Councillor Update, presented by Cr. Tamatha Paul

Cr. Paul updated members on her visit to Otari Bush that morning and the Te Kopahou Tracks hearings the previous week. She also gave a brief outline of the various workshops that Councillors would be involved in over the coming weeks.

There was some discussion around the location of the proposed temporary cycle network and how the group's views on indigenous biodiversity could be included as work on the transport network progresses. This is something that members can feed into when projects reach the detailed design stage.

The Climate Action Group are looking at ways that they can feed into Regional Plans and have requested that Greater Wellington Regional Council provide a presentation on public transport plans.

If ERG members want to have input into the LGWM decision about Cobham Drive it would be helpful if they spoke to the Mayor and Deputy Mayor as well as encouraging grassroots groups to be active over the next few weeks.

4. Policy Work Programme, presented by Geoff Lawson

Geoff outlined the large programme of policy work that Council is undertaking over the next 12 – 18 months. There was some discussion around the scope of Build Wellington and incentives for developers and builders to build greener buildings.

Members requested that Alison Howard speak to them about how Climate Emergency and Zero Emissions targets are feeding into WCC's workstreams.

- 5. Members Updates
- Transport not a great deal happening but the Cobham Drive proposal had been more controversial than expected.

- Waste Steven was not available to speak but Mike Mendonça indicated that WCC are undertaking a strategic review of how waste is managed in Wellington.
- Water Arron was away. There was some discussion around Three Waters Reform and the group's interest in where the Council are positioned currently.
- Resilience Lynn gave a brief outline of the Environmental Defence Society Conference and indicated that she would email further information to members.
- Urban Design Agency/Urban Growth District Plan is being notified later this year and the Natural and Built Environment Exposure Draft makes interesting reading.
- Mana whenua and Treaty Relations Cr. Paul provided an update on the appointment of mana whenua representatives and group members agreed that one of them should be appointed as portfolio lead on this.
- Biodiversity/Open Space George updated the group on the District Plan, Natural & Built Exposure Draft, and his regular meetings with Ecology manager
- Heritage Sally, David and Lynn are meeting with Mark Lindsay later this week for an update.

Hedi asked members if there was anything on the Policy Work Programme that they wanted to include in their work programme and reminded the group of their requirements to provide an Annual Report and Proposed Work Programme to Council. Lynn has started work on the Annual Report and requested input from other members on what they want to include and any updates on their bios.
