Meeting Procedures

The meeting opened at 5:03pm.

3. ELT Update

Kym Fell introduced himself to the group as the newly assigned ELT liaison for the ERG.

4. Zero Waste Strategy, Presented by Chris Matthews.

Chris provided an update on the Zero Waste Strategy, having presented to the group on the strategy in September 2022.

ERG members' feedback included:

- Had concerns regarding the lack of awareness of where waste goes for small businesses, and issues in collection causing improper disposal of waste.
- Thought current design of landfill was impractical and likely led to improper waste disposal. Suggested people assisting in waste disposal and/or redesign, incentivizing proper disposal, and consideration of transferring waste to other locations if unable to be processed in Te Whanganui-ā-Tara.
- Were unhappy with commercial composting.
- 5. Economic Wellbeing Strategy, presented by Melissa Davey and Kerryn Merriman.

Melissa and Kerryn provided an update on the Economic Wellbeing Strategy. This was last presented to the group prior to adoption by the Council, and is now in implementation.

ERG members' feedback included:

- Supported the focus on economic wellbeing and donut economics, and the alignment of this between the vision and strategy.
- Were concerned by tensions between a climate focus and tourism eg. impacts of cruise ships.
- Discussed what we want tourists to take away from their experience. Asked whether there is an opportunity to showcase Wellington and teach people through providing a sustainable experience.

6. Member/Liaison Updates

Leteicha shared the following updates:

- Councillors appointed to the ERG will be determined through a resolution of Te Kaunihera o Poneke | Council on 16 November 2022. The proposed delegations are currently available in the agenda for that meeting.
- LGWM join advisory group hui has been rescheduled for 1 December 2022. An updated calendar invitation has been sent to members.
- The Councillor Orientation session on advisory groups is now scheduled for 22 November 2022. Members are invited to attend to introduce their advisory group to Councillors.
- The Ngaio and Aro Valley consultation closes at 5pm on 21 November 2022, with hearings taking place on the 1 December 2022.

Members shared the following portfolio updates with the group:

- Transport:
 - Portfolio holders will share draft submission on Ngaio and Aro Valley Connection with the group.
 - o Johnsonville consultation is also open.
- Climate Change:
 - o Portfolio holders yet to meet with Council officer Democracy Advisor to connect.
- Waste & Circular Economy
 - Have met with Council officer regarding resilience. Council officer has wanted to delay one-on-one conversations about waste until after today's presentation.
 - Portfolio holders will consider where the group can best engage in the work programme.
- Biodiversity:
 - Portfolio holders have met with Daniela re: Our Natural Capital.
- Cultural Heritage:
 - Officers will be presenting to ERG at the meeting on 12 December 2022.
- Resilience:
 - Members felt discussions were a lot about water and waste, and there was maybe a gap in community resilience.
- Urban Design Agency/Urban Growth:
 - Portfolio holders have met with officers to get an understanding of the projects and team.
