The Subcommittee added the text in **bold** and the following is the explanation of the amendment.

Resolution 2 has been amended as the original Development Contribution assessment of \$77,418.75 included the 75% roading remission and a further 30% remission (based on a 0.7 EHU calculation) that was applied to the remaining Development Contribution roading component of \$8036.77. This 'double counting' in favour of Ryman Healthcare Ltd has been corrected by removing the 0.7 EHU calculation to the roading contribution, resulting in an amended Development Contribution of \$79,829.78 (inc GST).
