Whakarāpopoto | Executive Summary

4. This paper seeks approval from Kāwai Whakatipu for grants for applications made in the first funding round of this new fund. Applications for the fund closed on 10 February 2022.

Takenga mai | Background

- The Living Wage for Events fund was established as part of the Long-term Plan to support non-Council event to deliver events that provide the living wage for their staff and contractors. Criteria for the fund were adopted in December 2021 and applications opened in mid-December 2021.
- 6. Grants and funding are included in the Annual Plan to provide an appropriate mechanism for the Council to respond to community groups and organisations that are undertaking projects that meet a need identified by the community, align with the Council's strategic goals and community outcomes, and rely to some extent on participation and engagement by community organisations.
- 7. In assessing applications, Officers look at alignment of the application with Council policies and priority areas from the specific fund as well as the applicant's organisational capacity, ability to deliver projects, and the financial position.
- 8. To ensure funds are used appropriately, conditions on funding may be suggested for consideration as part of the approval process. For the grants recommended below, conditions should include confirmation of the funded events taking place and necessary Covid mitigation/planning or necessary public health measures under the Covid protection framework being in place.

Kōrerorero | Discussion

- 9. This Fund is available for three years during which time Officers will evaluate the impact with stakeholders and the events sector including the Living Wage Coalition. The fund value is \$300,000 per year for years 1 to 3 of the 2021-31 Long-term Plan.
- 10. The purpose of the fund is to:
 - Encourage events in Wellington City to adopt the living wage
 - Support event organisers to pay living wage for their staff and contractors who are directly employed to deliver, produce and perform at the event/s.
- 11. Living Wage for Events Fund applicants must meet the following criteria;
 - be a legal entity (or sit under a legal entity) including a community group, Māori entity, school, social enterprise or business
 - have an event that is taking place in Wellington City and mainly benefits the people of Wellington.
- 12. The Investment Criteria for the Living Wage for Events Fund are:
 - Provide support for events being delivered in Wellington City to provide living wage for their staff and contractors who are directly employed to deliver, produce and perform at the event/s and/or participating artists and performers
 - Applicants need to provide detailed information as part of the application to demonstrate how they will utilise funding to support the living wage.
- 13. Support for events that support one or more outcomes of the Council's Events Policy are prioritised through this fund. These events outcomes are:
 - Events that contribute and celebrates the arts
 - Events that partner with mana whenua to develop, promote and deliver cultural events that profile mana whenua
 - Events that support communities in creating their distinctive character
 - Strive to be an environmentally friendly event and sustainable in the long term
 - Events that promote inclusive, tolerant and strong communities.
- 14. The fund does not cover events where the primary purpose is to promote religious ministry or political objectives or for Council events, including those run by Council Controlled Organisations or hosted within Council controlled venues.
- 15. Covid 19 and the current Covid protection framework has impacted heavily on the events sector in recent months. Applicants were encouraged to consider public health plans and contingency plans as part of their applications.
- 16. A total of 11 applications were made, including five for separate events from the same applicant. These five have been grouped as one within this paper. Officers recommend supporting six organisations totalling \$45,267 as detailed in table 1 below.

Whakarāpopoto | Executive Summary

4. The Climate and Sustainability Fund (the Fund) is an initiative of Te Atakura – First to Zero. The intention of the Fund in years one to five of the 2021-2031 Long-term Plan is to support communities and businesses in Wellington City to undertake climate action initiatives that reduce, and/or support the reduction of, gross carbon emissions.

Takenga mai | Background

- 5. Initiatives must meet at least one of the following core fund criteria:
 - Advance Wellingtonians' understanding and uptake of the climate action challenge thereby contributing to meeting our 2030 and 2050 carbon reduction goals.
 - Preference for these grants will be initiatives that create impact beyond themselves.
 - Reduce carbon emissions significantly in the near term thereby contributing to the City's 2030 carbon reduction target.
 - Preference for these grants will be to initiatives that significantly reduce emissions.
- 6. The budget for the Fund is included in the 2021-2031 Long-term Plan \$250,000 annually for five years, with an additional small budget allocation for fund administration.

Kōrerorero | Discussion

- 7. The purpose of this fund is two-fold:
 - To support initiatives that might not achieve significant carbon reductions, but will
 create a culture of climate action, demonstrate scalable action, or reach a wide
 audience; and

- to support projects that reduce carbon emissions in Wellington City in the short term. Note that applications will not be accepted for initiatives that move emissions out of the Wellington City boundary and claim reductions.
- 8. It is anticipated that the allocation of funding over the lifetime of the fund will transition from initiatives focussed on creating a culture of climate change to initiatives that measureably reduce carbon emissions.
- 9. To be eligible to apply for this Fund, applicants must:
 - be a legal entity (or sit under a legal entity) including a community group, Māori entity, school, social enterprise or business
 - be willing to partner with Wellington City Council to share knowledge, learning and support our Te Atakura- First to Zero strategy
 - be based within WCC rate-paying area or deliver benefits within the Wellington City Council rate paying area.
 - have a proven track record of delivering similar projects.
- 10. Priority will be given to projects that:
 - demonstrate equity across communities in relation to access to climate action information and ability to act
 - are governed by, and/or developed in partnership with mana whenua
 - lead towards a zero-carbon economy by 2050
 - demonstrate collaboration and co-funding (including in-kind)
 - have a plan to be self-sustaining and financially viable post Council funding.
- 11. Applications will be assessed based on the following criteria:
 - Impact there is clear evidence that the initiative will contribute to building a culture of climate change action and/or reduce carbon emissions.
 - Scalable the initiative has the ability to be scaled (or replicated) to increase the impact over time.
 - Legacy the initiative can deliver ongoing benefit and/or demonstrate the potential for lasting long-term impact.
 - Measurable change the initiative has tangible outcomes that can be measured and produce learnings that can contribute to a broader movement of change.
 - Unintended consequences the applicant has identified (where possible) and considered unintended socio-cultural, economic or environmental impacts (positive or negative).
 - Deliverable the initiative is ready and able to be delivered within the timeframe stated.
- 12. A Community Activator/Funding Advisor role within the Community Services team has been established to support applications, community organisations and projects committed to reducing carbon emissions.

13. The Fund is being managed through the Council grants management system and have been assessed, reviewed and moderated by a panel of External Assessors who bring a bringing deep climate action perspective, including Māori perspectives and are from a mix of business and public sector. This group have reviewed all application material and scored each application. Officers recommendations are based on this scoring and consensus about which projects most strongly delivered to the objectives of the fund.

14. External Review Panel members

- Kaapua Smith (Ngāti Porou, Ngāti Apa, Ngāti Awa) has a background in corporate sustainability and community and tangata whenua engagement. She has previously worked as the Head of Sustainability at Contact Energy and held roles in the Office of the Minister of Maori Affairs and Minister of Whanau Ora. She is currently a Trustee of WWF New Zealand and Nga Wairiki ki Uta Trust, a Hapū Trust based in Whanganui and works at KPMG NZ. Kaapua's work on this external review panel is outside her role at KPMG.
- Karl Check runs a specialist climate change consultancy Foreseeable, and started his sustainability career in Wellington at KiwiRail. Karl has also performed the role of mentor in climate hackathons and is well versed on the initiatives that will deliver impact and create co-benefits for communities.
- William Woods is currently Strategic Planning Manager at CentrePort Ltd. William
 has over 25 years' experience working in resource and environmental
 management, in both public and private sectors. He brings extensive knowledge
 of climate action and sustainability and has a particular interest in promoting
 effective collaboration between business and community.
- Kaeden Watts is a climate change, hauora Māori and Māori equity specialist, and brings with him experience tackling climate change issues domestically and internationally. Kaeden has experience activating change at a range of levels, from grassroots campaigning to international negotiation. Kaeden is currently working within our Cimate Action team for three months supporting a range of projects.
- Alison Howard is Manager Climate Change Response at Wellington City Council.
- 15. A total of 11 applications were received in this funding round which closed for applications on 10 February, the first of the 2021/22 financial year. These applications requested a total of \$605,896. A further round has been scheduled which is open for applications with a closing date of 31 March with decisions made at the May 17 2022 meeting of Kāwai Whakatipu/Grants subcommittee.
- 16. Officers recommend supporting five organisations totalling \$174,250 as follows (more detail on all the applications is available in table 1 below):
 - Sustainability Trust \$95,000 to transform their existing eco-centre into a climate action centre.
 - Wellington Chamber of Commerce \$50,000 to support 40 small-to-medium
 Wellington businesses to go through a "Sustainability Bootcamp" that results in tangible and tailored climate action plans for each business.

- Eco-church NZ \$20,000 to support grassroots efforts by churches in Wellington to understand their carbon footprint and develop climate action plans.
- PlantMe Growathon \$5,000 to run a gamified online platform that tracks the carbon benefits of backyard food production. This also aligns to the objectives of the Sustainable Food Action Plan.
- Lodabike \$4,250 to undertake research on barriers to ebike ownership. The
 intention is to connect this strongly to Council's existing behaviour change work
 programme.
- 17. Officers also recommend that two applicants are asked to further develop their proposals and resubmit them in the next round.
 - Enviroschools This programme is making a broad case for higher levels of Council funding for their programme, and needs to be considered in the context of all the sources of Council funding available to them. The application as written does not demonstrate strong links to climate action. Request is for \$100,000 from this fund, in addition to the \$59,699 they receive already through the Social and Recreation and Natural Environment Funds. Officers will work with Enviroschools to develop their proposal and strengthen carbon emissions reduction element in order to better meet this Fund's criteria and objectives which can then be considered at the May 17 Grants meeting at the same time as their multi-year contract application to the Social and Natural Environment Funds will also be considered.
 - Cargo-bike library by Rebicyle The project plan is quite ambitious, and more information will be requested on the pathway for trial participants to then own ebikes. Officers would also like more detail on how equity issues will be addressed.
- 18. In alignment with Fund criteria, the panel prioritised climate action impact and deliverability, and were very impressed with the depth and quality of the applications given the short time between the Fund being advertised and this funding round. The panel also noted that more effort and time spent on finding and building relationships with potential applicants should help increase applications with an equity or mana whenua focus for future rounds.
